



UPON REFLECTION

What a complete pleasure it has been—even in the difficult times we are living through—to begin my role as the 14th President of Saint Mary's! In my earliest days at the College, I mobilized a versatile team to take on the head-over-heels effort to reopen the campus for the fall semester—a once simple expectation that, this year, required extraordinary preparations. So now, a few months into the role and several weeks into the semester, I welcome this occasion to reflect on the opportunity of joining a strong institution and the responsibility of continuing a tremendous legacy.

Since arriving on campus, I have engaged in hundreds of conversations that have helped me begin to understand the singular and distinctive qualities of Saint Mary's and the impact the College has made on generations of women. I have asked everyone: as we look to the future, what should we *revere* and what should we *revise*? And the answers have remarkable consistency. We should always be a Catholic College for women, firmly planted in the liberal arts tradition. We should also emulate the Sisters of the Holy Cross in evolving to meet the needs of the times. Many people I spoke with offered specific areas of need that we are positioned to address—from building and modeling a culture of belonging and mattering, to establishing a national reputation for advancing women across the life-cycle, to ensuring we fulfill our goal to be a just and equitable community.

Students and alumnae tell remarkable stories of what happened to them at Saint Mary's: they found their voices; they ignited their passions; they expanded their faith horizons; they soared in ways they never could have imagined. My own shorthand for this has become: *They discovered their gifts and how to give them to the world.*

That phrase turned me toward the question of what I have to give to Saint Mary's. Well, recently I revisited a 2015 interview from my favorite podcast, $On\ Being$: host Krista Tippett speaking with Mary Oliver, the

award-winning New England poet so beloved (and now missed) by readers across multiple generations. Oliver made me reflect—as she has so often over the years—on the virtue of paying attention, of bringing one's whole self into whatever the day offers. "To pay attention," she writes, "this is our endless / and proper work."

And it dawned on me that the "gift" I could give to the College was just that: to pay attention. To learn the histories. To bring my whole focus to interactions with others and to this sanctuary we call a campus. To look with open eyes, to listen with open ears, to embrace our shared challenges with an open mind and an open heart. "Attention," Oliver writes elsewhere, "is the beginning of devotion." And I realize my devotion to Saint Mary's has been born out of my attention. I imagine myself the scholar in Oliver's poem "Mindful":

"Oh, good scholar,
I say to myself,
how can you help
but grow wise
with such teachings
as these—
the untrimmable light
of the world,
the ocean's shine,
the prayers that are made
out of grass?"

I hope to grow wiser every day.

"The great American novelist Marilynne Robison said, 'The greatest test ever made of human wisdom and decency might very well come to this...We must teach and learn broadly and seriously.' It was at Saint Mary's that I was taught seriously and learned broadly and it is essential that you who are graduating today understand not only what you have been taught but how a foundation of learning and caring prepares you like nothing else for what will be asked of you."

Over the past one and three-quarter centuries, there has never been a Saint Mary's College Commencement like Commencement 2020.

In some ways, it looked the same, the robed presenters filing out of Le Mans Hall toward their chairs and Interim President Nancy Nekvasil approaching the lectern to address the Class of 2020's 353 undergraduates and 47 graduate students. Except there were no students in the audience. There was no audience—at least, none on site.

Instead, hundreds of students and their families tuned in virtually from across the country via a web link. Yes, it was a difficult time to pull off a commencement in the midst of a global pandemic that had shut down schools and businesses everywhere. But Saint Mary's College organizers did it.

The presenters remained a respectable distance away from each other during the ceremony. Photos of the Outstanding Senior, Lumen Christi, and Madeleva awardees were displayed on the live video, while the speeches of the three valedictories and the Commencement speaker were offered via previously recorded messages. As Tracy White, senior academic advisor, performed the Presentation of Graduates, names were displayed on the screen.

There might not have been as much noise and commotion in front of Le Mans Hall following the ceremony, but as Nekvasil said at the end, "I hope there is lots of joy and clapping in your homes."

But whether a commencement is traditional or very untraditional, as this virtual one was, nothing can diminish the days, months, and years of toil and triumph on the part of the 400 undergraduate and graduate students. Perhaps their Commencement will be all the more memorable when their children, in years to come, ask "What did you do during the coronavirus pandemic, mommy?"

Congratulations to the 2020 graduates as they face a world unlike any entered by previous Saint Mary's College classes. Now more than ever, the world will need their courage, compassion, creativity, and brilliance. And we know, as Saint Mary's women, they will deliver.

Rising to the Occasion: Reunion 2020



We all hope the odd circumstances leading to the virtual Reunion of 2020 don't occur again. But in the event they do, we know that Saint Mary's women, as always, will rise to the occasion and make the best of any unique situation.

When the decision came in April that Reunion 2020 would have to be postponed, staff immediately set to work to devise an alternate plan. Why not a virtual Reunion?" they thought. If we can't be together physically, we surely can—in this day and age manage to connect digitally. And so "a virtual Reunion" was created, an event that won't be soon forgotten, especially by the "0's" and "5's" who participated from their homes and gardens and wherever they found themselves to be.

Ten class years held hour-long sessions, or more, facilitated by Kara M. O'Leary '89, executive director of alumnae and college relations, Lexi Grady Haitsma '17, associate director of alumnae relations, or Madeline Zuniga '16, former assistant director of annual and reunion giving.

"It was amazing," said O'Leary. "There were alumnae who attended who probably would not have come to the physical Reunion because of distance or family obligations or other reasons. Each Reunion was so warm, heartfelt, and full of camaraderie."

One alumna in Connecticut tuned in from her garden. Her classmates asked for a tour, so she walked around with her computer to show off her flowers and plants. Others introduced their dogs or cats to their classmates, and their children, too. It was as though they were able to gain a glimpse into each other's lives, a glimpse that would not have been afforded in a physical gathering.

"A good chunk of time was spent with alumnae asking about what was going on at Saint Mary's," O'Leary added. "They wanted to know if certain places in South Bend still existed and things like that. It was cool. Lexi and I were also able to give updates about the College today."

The energy on the Zoom calls was palpable. "There was so much conversation and catching up, even for alumnae who might not

know each other well. And a lot of laughter! Some women said they put on makeup and dressed up for the first time in months!" O'Leary said.

While Reunion 2020 was certainly different from those that attendees had previously participated in, the Class of 2015 had no such comparison. Here it was, their very first Reunion, and they couldn't experience the joy of gathering back on campus and hugging their classmates.

Of course, a very popular event for each class was meeting President Katie Conboy. "There was so much energy with President Conboy's sessions," O'Leary said. "I was so impressed that the alumnae, right away, asked her, 'What can we do to help you?' They were reaching out, saying, 'We're here; tell us what you need."

The College even managed to include the traditional educational sessions that are a part of Reunion weekend. Professor Catherine Pittman led attendees through a session on coping during the time of COVID; Associate Professor Pat Pierce discussed issues related to the 2020 election; and alumna Kimmi Martin Troy'00 led participants through a yoga session.

Despite the circumstances of Reunion 2020, planning is already underway for the 2021 event for the "1's" and "6's." But 2021 will also serve as a "re-do" for the "0's" and "5's."

"A second weekend next June is being set aside for the '0's' and '5's' who missed out on being able to come back to campus," O'Leary said. "They will have the full Reunion experience."

She reflected, "I think attendance will be very good next year for these alumnae. I think people realize that you can't take anything for granted. This unique situation will help them grow tighter as a group. The 2021 event will be all the more special because of what they went through together in 2020."

Golden—with a twist

The Class of 1970 had been working diligently for more than a year to plan for their golden Reunion in 2020. The disappointment that came when it began appearing as though a physical Reunion would not happen was felt deeply across the class. But Saint Mary's women are not ones to wallow.

"Our goal was to replicate what our on-campus experience would be to the best of our ability," said Karen McCarty '70. Using survey tools and interaction among classmates, organizers pulled together an agenda that contained some of the highlights they would have experienced on-campus. More than 10 Zoom sessions were held, including multiple lounge sessions where classmates could hang out and reconnect. Over 60 classmates participated in the sessions that were hosted over three days

"We received great feedback," McCarty said. "Many classmates told us they were able to reconnect with each other. We now plan on offering Zoom sessions at least bimonthly to keep the momentum going until we can hopefully meet in person in June 2021!"

Distinguished Alumna Award

Mary L. Burke '85 graduated with a bachelor of arts degree in humanistic studies from Saint Mary's, then later received an MBA in 1995 from the Booth School of Business at the University of Chicago. Since graduation, Burke has not only supported Saint Mary's through her involvement in alumnae clubs and on multiple boards, she tirelessly encourages her sister alumnae to do the same. She is an active fundraiser for the College, and the President's Medal recipient in 2016. Most importantly, she is recognized for the service she has given the countless students at Saint Mary's. She is present for multiple student-centered events on campus every year, and gives a great deal of her time counseling, writing letters of recommendation, and listening to students.



Alumna Achievement

Hon. Muriel D. Hughes '80 graduated with a double major in business administration and philosophy; she received her JD from the University of Detroit Mercy Law School in 1983. In 2006, Hughes was appointed to the State of Michigan 3rd Judicial Circuit Court by the governor and has since been re-elected by the people of Wayne County three times. Judge Hughes currently serves in the Civil and Business Divisions of the Court. Previously, Hughes successfully practiced law for 23 years with the firm Hughes & Hughes P.C., specializing in general litigation, business, real estate, and probate law. She also served as a Wayne County Public Administrator. Judge Hughes mentors young attorneys through the Detroit Bar Association and has served on numerous committees to ensure access to justice. 


Outstanding Young Alumna Award

The stand against racism

On June 1, the College Cabinet began by drafting a statement to reiterate and strengthen its commitment to stand against racism. President Katie Conboy—on the first day of her new role directed the statement's creation, which invites and challenges the entire College community to commit to a number of actions intended to enlighten, engage, inspire, and effect lasting change. This statement charges everyone—faculty, staff, students, and alumnae—to pull together to bring about fundamental shifts. Conboy realizes that this is no small challenge.

Redgina Hill, executive director of inclusion and equity, is helping to lead this charge. She points out that success or failure in this endeavor relies on every person being willing to take a fresh look at themselves, what they observe around them, and the courage to make a stand. Too often, efforts fail in organizations because the onus is put on the shoulders of one person. "Success is much greater when everyone owns the responsibility," Hill said. "We are striving to weave our efforts in diversity, equity, inclusion, and justice into the fabric of our institution."

The seven important actions outlined by the commitment statement are both tangible and intangible. They include engaging in continuous learning to understand the challenges of communities impacted by racial injustice. The statement nudges the College community to develop an awareness of their own biases and work toward overcoming them, as well as calling out racism wherever they see it. It is vital, too, to honor the experiences of others by listening to, and validating their narratives, and fostering friendships with people from diverse backgrounds.

The College also has committed to supporting organizations that are addressing issues surrounding racism, like the South Bend-Elkhart Regional Partnership (SBERP). Still in the planning stages, this and other partnerships may involve campus events or the College participating in the organizations' activities. "We will walk alongside them to raise the banner for diversity, equity, inclusion, and justice," said Hill.

In the statement's final directive, the College encourages individuals to support policies and laws at the federal, state, and local levels that address disparities in educational opportunities, health care, housing, and law enforcement.

These seven directives—connected to Saint Mary's mission and core values of learning, community, faith/spirituality, and justiceform a foundation for shifting hearts and minds as we journey down the path toward a more just campus and world.

Granted, this path will be long and it may not have a true end point, but the College will continually gauge its progress, because it is not enough to just 'do'; one must also monitor and measure, and adjust as needed. "Accountability is key to the success of our commitment," Hill said. "We have set measurable goals for the College's new strategic plan, which includes a significant section on diversity, equity, inclusion, and justice."

Educating and empowering

The Cabinet's Stand on Racism was quickly followed by an open letter from the Board of Trustees later that week. In it, they outline additional commitments of the College including open dialogue. Beginning last June, Hill and President Conboy held a series of virtual town halls among faculty and staff, alumnae, students of color, alumnae of color, and faculty and staff of color.. The latter were asked to share their experiences at Saint Mary's. "The shared narrative that has lived on throughout the generations of alumnae and current students is heartbreaking," said Hill. "It was difficult to hear that someone who just graduated in 2020 had similar experiences as someone who graduated in the 1950s or 1970s. We have to do better at educating our College community, advocating for our students, and implementing structural changes that will enhance the climate for inclusion on our campus."

Hill also brought to campus (virtually) last summer a five-week anti-racism journey that she co-facilitated with President Conboy. Each week, approximately 140 participants were provided with exposure to pertinent movies, documentaries, podcasts, and articles, then asked to follow a five-step plan: Watch. Read. Listen. Pray. Discern. At the end of each week, Hill and/or President Conboy moderated a discussion among the participants, who reflected on the current reading or viewing. Much of the material provided was uncomfortable at the least and gut-punch visceral at the most.

After watching the documentary called "13th" one participant told Hill, "I had several 'Aha!' moments about the 'war on drugs.' This has been so eye-opening. Understanding how the 13th amendment has led to another form of slavery breaks my heart."

By week three, faculty and staff members began commenting that this educational journey was prompting them to question how they talked, what they celebrated, and even how they instructed. Multiple participants began to discuss what they might do differently at work and in the classroom. Many also were sobered to learn that attitudes and actions they thought were acceptable are now being challenged. Professors who attended the five-week

journey also reflected that they now have a more critical take on how to approach their pedagogy in the classroom.

Removing barriers

Some organizations might find it tempting to increase the number of diverse people within their walls and call their diversity effort solved. While it is true that the College welcomes greater diversity among faculty, staff, and the student body, as Hill notes, "Compositional diversity is not enough and can be extremely dangerous if we are not willing to address the issues that cause students to experience racism or feel excluded. We have to be unafraid to change the culture for all to experience belonging."

During the five-week antiracism journey, some faculty members were inspired to review their curriculum to be more inclusive "We are looking at the barriers that are in place that are potentially keeping some students from feeling included," Hill said. "We want to see how we can be more inclusive in our curriculum in bringing in voices and faces, different ethnicities that may not be already represented here. Plus, the learnings that we gained from the five-week anti-racism journey have created traction for more training for faculty, staff, administration, and the board." Training is currently being planned for the campus.

Hill is also engaging the President's Council on Inclusivity and Multicultural Diversity (PCIMD) in this commitment. Vital to sustaining Saint Mary's commitment against racism, the PCIMD is a long-standing advisory and leadership team—comprising Cabinet-level administrative members, faculty, staff, and student leaders—that develops, oversees, and monitors College-wide efforts on inclusivity and multicultural diversity. Hill chairs the council.

Learning from our past

It is difficult to reflect on the nearly 70 years that have passed since the first woman of color, Juanita Boozer Bay, graduated from the College in 1952. Today, in 2020, women of color at the College represent 22 percent of enrollment. But, as Hill said, and as alumnae reminded us, compositional diversity is not enough. Just because more women of color choose Saint Mary's does not mean they will not experience subtle or not-so-subtle moments of racist attitudes.

For those alumnae who do not believe that racism has existed and still occurs on campus, Hill recommends they pay attention to the narratives of those who have lived it. "Connect to your local alumnae base or your class year, because you likely will find someone within your class, someone who lived in your dorm or that you had a class with or ate with in the dining hall, who probably had some negative experiences," she said. "Reach out among your classmates and ask to have a conversation about their time at Saint Mary's, then listen and don't invalidate their experience."

The focus as the College moves forward, however, is not to lay blame, but to chart a course for effecting long-term sustainable and measurable change with the goal of eliminating racist attitudes and misbeliefs, of changing hearts and minds.

Hill said she has been excited at seeing the "many light bulbs that went on for so many people" during the five-week journey and through other activities. To see this enlightenment translated into the new school year, its impact on how faculty approach the classroom, and even how individuals approach conversations, "I feel good that we are moving in the right direction."

This "right direction" is an ongoing effort for Saint Mary's—and the rest of the world. There won't be a finish line to this work, rather a sustained awareness and active education for the current campus community and all the generations to follow. It means the College must always lead the exploration of biases, learned behaviors, and lack of awareness of those who step onto these beloved grounds. But it also means that the College must encourage our larger communities to do that same—including our alumnae who live around the world.

Saint Mary's invites you to join the College in the fight against racism. Online, you'll find the five-week antiracism educational journey, Our Stand Against Racism from the Cabinet, and the Trustees' open letter with the College's commitments to take sustained action. You're encouraged to review and adopt these tools into discussions with friends and family, in your workplace, and everywhere you interact with others. It is no small feat to make the world a just and inclusive place but by broadening perspectives, Saint Mary's hopes to help make an impact on campus and in our communities.

At Home with President Conboy... Our Mom

In the age of COVID-19, the open door policy that would ordinarily be President Conboy's signature welcome to the Saint Mary's College community may need to be more virtual than literal. But the spirit will prevail: in the Conboy-O'Grady household, an open door has been our way of life—literally—for as long as we can remember.

Have a college friend without a place to go over a long weekend? Bring them to stay with us. A promising new love interest? You'd better invite him to Thanksgiving. Four international students from India who can't get home over winter break? We're picking them up and driving them back to 9 Oak Road for Christmas dinner—and gifts! When one of her previous institutions welcomed a group of 20 young women from across Africa during her first month as provost, she insisted on hosting some of the students under our roof—and on making them the *Panang* curry she mastered during a cooking class in northern Thailand. The more cultures represented and the more paths crossing in our home, the better.

For our well-traveled mother—an Army brat who knows what it's like to want to feel at home—this is simply how a life should be lived. There is no space too small to crowd in another person; no table too fancy for an extra, unmatched chair. She and our dad preside over Thanksgiving dinner at the head of the table, sharing a small piano bench so that everyone else has a seat to lean back in after feasting on her Michelin Star-worthy



smorgasbord. We'll drag that bench back into the living room after dinner for a singalong in which she is equally as likely to solo as to harmonize.

And that seems like a good metaphor for what we've seen of her first few months in the top leadership role at Saint Mary's College. Arriving on campus in the midst of a pandemic ravaging the country and a national reckoning over racism, she stepped up and stepped in for the biggest solo of her life. But she has also sought countless opportunities to harmonize, to learn from her new colleagues and the students and alumnae she serves, and to give other voices the chance to take the lead. She has affirmed wholeheartedly that Black Lives Matter, with the conviction that this is the time for bold, principled leadership, not vacillation among conflicting views of the world.

Our mom has always sought to understand the lived experiences of others. For us, there is no clearer example of this than her decision to visit each of us during the transformative college semesters that we spent abroad. Her first trip brought her to Senegal to visit her eldest daughter. In Dakar, Mairéad's host family referred to our mom as "Mommy Katie," but also lovingly bestowed upon her the same Senegalese name as their matriarch,

Siobhán, Tom, Katie, Caitríona, Mairéad. In Caitríona's arms is Huloo.

Coumba. Two years later, she booked a family trip to Morocco for Thanksgiving during Caitríona's first semester there, where she surprised and delighted her daughter's hosts and classmates with American-style pumpkin pies. (Mairéad couldn't join because she was on a teaching fellowship in Thailand, but our mom took a multi-day flight across the world to see her six months later.) And, of course, she couldn't skip visiting her youngest daughter in Cameroon after seeing the older two in their new contexts. In Yaoundé, she cooked her famous spaghetti and meatballs for a dozen members of Siobhán's host family, with a dash of local hot *pepe* as an extra touch. For each of us, her presence in the moment, learning about a new culture alongside us, felt like a gift we shared. But what we realized soon after returning to the US was that having someone back home who could understand our stories firsthand, who could picture the people and the places we'd come to love, who could listen when we missed our far-off friends the most—that was a gift that kept on giving.

We know that this is precisely the spirit our mom brings to Saint Mary's: she is committed, first and foremost, to learning a place and its people. Most people need to get to know a place before it can feel like home; she makes a place her home as a way to get to know it. We've seen her do this in the cities and the countries that mean so much to us, and in places like Paris and Dublin and our father's native Prince Edward Island, where she is the one who organizes and facilitates large family gatherings on our annual pilgrimages there. She has never met a kitchen, or a community, she couldn't make her own.

Since her South Bend condo wasn't ready by the time her job was starting on June 1, our mom drove 14 hours across the country, alone, and moved directly onto the Saint Mary's campus. In a way, she was coming home: wedding her previous professional stops at a Holy Cross institution and a women's college, Saint Mary's sits just across the road from Notre Dame, where she and our dad earned their PhDs and where they were married in the Basilica 35 years ago. Living on campus allowed her to demonstrate her commitment to the school and to provide stability and trust during one of the most uncertain eras in recent memory. Soon, she and our dad (and their two cats) will be fully settled into their condo, and we look forward to the day when they can host us and so many of you in the Saint Mary's community safely. But in the meantime, Riedinger House, where our mom lived during her first couple of months on the job, will be her office this year. How perfectly apt that in her first year as President, her office—doors open wide—will be a home.

For Rebekah and Penny, two women whose Saint Mary's experiences span 55 years, Reunion would have brought them to the place that has a special place in their hearts.

Rebekah Rackar Gaspar '05 met **Rosemary "Penny" Schilling Ferriter '50** at Westminster Village in West Lafayette, Ind. In her work as Assisted Living Life Enrichment Coordinator, Rebekah works closely with seniors to engage them in activities and quality of life programming.

And Penny loved to tell stories. She told stories about her college days. Recalling a 10 p.m. curfew, when the nuns would call the students in for the night. How sometimes after the sisters came around for "lights out," she and her friends would sneak into their closets to stay up later talking. How they used to take the tunnels to class on cold days.

Rebekah recognized the setting of those stories. "You went to Saint Mary's, Penny? I went there!" The two women have been bonded ever since. Although they were not able to attend their Reunion this year, they got to spend plenty of time together during quarantine. With no guests able to visit Westminster Village, Rebekah said Penny feels like family to her.

Penny was an education major at Saint Mary's. Her parents believed in the importance of an education, and she soaked in all the experiences she could. She fondly remembers taking the bus to town with her friends, daily morning Mass, walking down The Avenue, staying warm in the tunnels, and the friendships she made.

Rebekah has different memories of her Saint Mary's experience as a fine arts major, but she appreciates the uniqueness of the Saint Mary's education. Also from a small town in Indiana, going to Saint Mary's challenged her and broadened her perspective. The small class sizes allowed her to express herself and learn in an intimate setting. The individualized approach is something that she uses in her work, tailoring activities and programming to the needs of her assigned cohort.

After graduation, Penny moved back south to West Lafayette and taught in a second grade classroom. She married her Notre Dame boyfriend Maurice Ferriter in 1951, and she made the decision to stay home with their first son who was born shortly after.



Dr. N, AWoman of Faith

In late May, vehicles lined The Avenue and signs hung from car windows with well wishes. "Nancy for Sainthood." "Thanks for your leadership." "We love you," read some of the signs and car paint doodled on windows. During a pandemic, a send off looks different for the Saint Mary's community, but more than 150 faculty and staff masked up and drove through Le Mans Circle to wish Interim President Nancy Nekvasil well as she departed from her role as interim president.

After 36 years at the College, leaving campus during a pandemic is bittersweet. But Saint Mary's will never be far from Nancy's heart. "Blessed," is how she would describe her time on campus. "The send-off was just right for me. It filled my heart up," Nekvasil said.

Beginning in 1984, Nekvasil taught physiology at Saint Mary's. She is remembered by students as an inspiring mentor, a faithful leader who encouraged students to follow their dreams, and someone who reminded them to never give up on themselves.

Amy Renee Lalick-Prinzi '97 was mentored by Nekvasil as her health professions advisor and is thrilled that her daughter will follow in her footsteps attending. "I'm so excited my daughter is at [Saint Mary's] this fall. I am hoping she has as wonderful



an experience as I did and will become the woman I know she can be."

She goes on to say, "Dr. N made sure to keep me on the right track and not to get discouraged when things were not always perfect, as I like them to be. She made sure to assure me when I was down about my future."

Lalick-Prinzi was accepted into three dental programs thanks to guidance of "Dr. N." After receiving her dental degree, she further pursued public health and received master's degrees in public health and education as well. Nekvasil's leadership has inspired Lalick-Prinzi to give back. "I still would love to be a mentor like her and have the degree in education to someday mentor other students. I would love to bring my public health skills to a school and to get more dentists to do what I have done, caring for the least of these as Jesus said in the Bible to do."

Lynne Stokke '01 worked with Nekvasil when she was a student in Eureka Science Academy, which began in summer 1999 to offer science education to elementary-aged students in a collaboration between the biology and education departments. Offered for a couple of weeks during the summer, Saint Mary's students led elementary-aged students through hands-on experiments, outdoor exploration, and art projects.

The lessons learned that summer have stayed with Stokke. "Dr Nekvasil is a great woman of faith and she taught me that one way I can love others is by sharing my faith with them," Stokke said.

In 2017, Nekvasil was named provost and senior vice president for academic affairs, and then stepped into the role of interim president in October 2018. She reflected recently, "One very important thing that I have learned in my personal faith journey and that has been reinforced by the Sisters of the Holy Cross is that we are to meet people where they are and walk beside them in their life."

The most meaningful part of her work, Nekvasil says, is the personal relationships that she has formed with students, faculty, and staff from all areas of the College. The opportunity to interact with them from different perspectives was "an incredible experience."

"I'm a firm believer that everything in which you engage changes you and reshapes your lens and how you view life from there on out," she noted. "It has been a privilege to take the time to get to know so many people at the College. It has enriched my life to walk through the college journey with my students. My job was just to be open and be willing to listen and be a safe place if they needed that."

She estimates that she has reviewed hundreds of personal statements for graduate school over the years. "Getting to know the students has broadened my view of God's love for all of us. And what I appreciated and loved so much in my experience as interim president at Saint Mary's was getting to know more of the people who make Saint Mary's what it is. Having the opportunity to work at Saint Mary's for so many years has changed my life and has taught me much about loving others."

The impact of Nekvasil on her students is lasting. "Dr. N was always very encouraging," Stokke said. "Science has not always been my favorite subject, but she taught me I could always appreciate it. The joy she has for life came through in the science lab."

Known for teaching physiology, Nekavsil's interest in scientific education discovery is informed by her faith. "I taught physiology (the study of how things work) my entire time in the classroom at Saint Mary's, and teaching about how the change in one ion can alter the heart beat or how one minor change in the genetic code can cause a fatal condition is mind-blowing to me. I will never tire of learning—or teaching—about such things."

For Nekvasil, science and faith will always be intricately linked. "My deep interest in science was actually kindled by my belief in a God who created the amazing variety of scientific phenomena we can observe, including all the intricacies of how the body works."

Nekvasil's students are a little younger these days. She is now helping her granddaughters in Tennessee in their science discovery—teaching them how to use microscopes and engaging them in kitchen chemistry. The hope, she says, is to inspire in them a love for science.



Starting college during a pandemic looks a little different. For the Class of 2024, it looks like physically distanced events, a masked-up move in, and daily health check ins. On campus, it can be hard to recognize new faces under masks and get to know your neighbors with health and safety restrictions in place.

First year Riley Kostic '24 said her biggest challenge was making new friends and feeling part of the community. "Everyone was keeping their distance in the beginning and I was worried about not making friends. Luckily, I found a great group of girls that I am able to rely on in these uncertain times."

And although the pandemic has been isolating in some ways, Lydia Csaszar '22 said she has seen students come together in other ways.

"One thing that I have noticed is that people are physically distancing at lunch, but still eating with each other and talking instead of just sitting and working on their laptops or playing on their phones... So we are all unplugging and talking."

Political science professor Marc Belanger said he's seen his students step up and engage in Zoom discussions. "The surprise to me is that there has not been a real [difference] in the quality of student work. ...Considering all the challenges they face, and the anxiety, I think students really are trying to do their best work and succeeding more than I might have expected."

The Women's Choir has adjusted their practice schedule to only once a week with the full choir, spaced out in O'Laughlin Auditorium. Students have to wear masks as they sing, but when they come together, it is a beautiful experience.

"The students are just so glad to be able to sing together again, even in this strange way," Nancy Menk said. The Women's Choir came together as a choir to produce the first virtual choir video, "The Bells of Saint Mary's" of course!


