UPON REFLECTION

For more than 30 years, I have worked at Saint Mary's. In my time at the College I have had the privilege of walking with students on their varying paths during their four years and beyond as alumnae. Then as the director of campus ministry and now in my role as vice president for mission, I have seen Saint Mary's women respond to the needs of the times, inspired by the work of the sisters, in many different ways.

If I had to choose one word to sum up the richness of the Saint Mary's community, it would be invitation. In so many ways, our students are invited to grow, learn, engage, and discover new things about themselves and the world around them. In my own experience, as a longtime member of the community, I have been blessed to work in a place where I have found and strengthened my voice as a woman. We recognize, in the 175th year, the many ways womens' voices have been strengthened and are transforming our world today.

I think of one student who is organizing a project on campus to commission a mural for our 175th anniversary. Her willingness to raise her voice and say, I think we need a visual sign of our commitment to inclusion and diversity, invites and inspires me. Another alumna who graduated in the 1990s comes to mind. She responded to an invitation to serve as a communion minister during her four years at Saint Mary's. She returned to her parish, where no women served in this capacity and posed the question to her pastor to share her love of the eucharist as a communion minister. Her request of the pastor changed the face of liturgical ministry in her parish. I know alumnae who have responded to invitations to share their gifts and talents, where they have been and are deeply engaged in transforming education and healthcare in developing countries, working for justice and the dignity of women incarcerated in Brazil, or embracing patients in burn or critical care units as chaplains.

I invite you to think about the way Saint Mary's has drawn you into a deeper understanding or onto an unimaginable path. In this issue of *Courier*, we hear about the way a rejection from Notre Dame helped an alumna discover her true calling and vocation as a nurse practitioner. Although things don't always turn out the way we thought they might, we know we are not alone. Our trust in God's invitation to seek truth and goodness, to follow our passions and share our gifts with others, invites us to be a beacon of hope in the world, as the Sisters of the Holy Cross continue to witness in our global world.

This semester award-winning actress Sutton Foster came to campus as the Margaret M. Hill Endowed Visiting Artist. Her honesty on stage and in working with our students in a master class, inspired our students to appreciate the authentic human experience, rather than view celebrities on a pedestal. She told the crowd, "There is nothing you can't do that a man can — or even nothing you can't do better than a man. [As women,] we need to rewrite that story. Don't limit yourself, because the world itself is starting to let go of limitations."

At this time in our history, as womens' colleges are seeing renewal in interest and women are continuing to raise their voices publicly about injustice they see and experience, we, too, reflect on what the needs of young women are today. Our Interim President Nancy Nekvasil has established strategic priorities that will embolden the College as the student-centered institution we have always been. Her focus on student access and success, her deep commitment to our Catholic Holy Cross tradition, as well as our financial strength, will bolster Saint Mary's for another 175 years of empowering women.

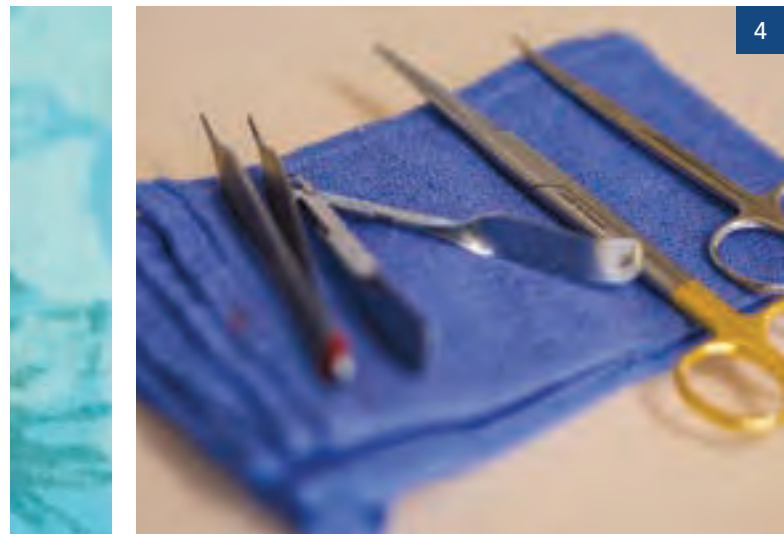
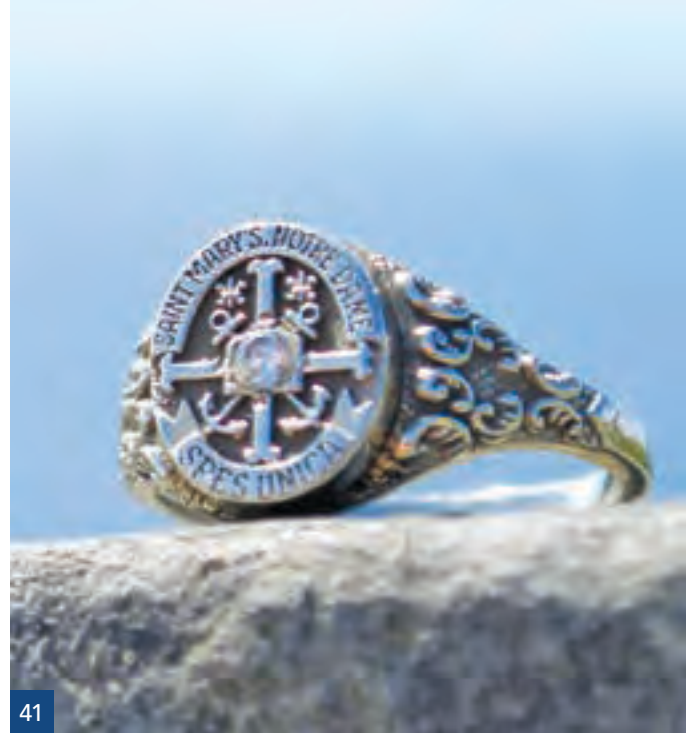

Twist of Fate

Growing up in Pittsburgh, **Claire Gates '09** was a die-hard Notre Dame fan. It's where her grandfather, father, and three of her four siblings went. Only one thing beat those six Saturday mornings in the fall when Gates and her family would spend the day at her grandparents' house watching the Fighting Irish — and that was when they drove six hours to South Bend during the years her brothers and sister attended Notre Dame. "Nothing felt more serene than those fall days with the crisp air and orange leaves surrounding us," she recalls. She felt connected.

So in high school, Gates had one destination in mind for college and that was the University of Notre Dame. She took all honors and advanced placement courses and did everything she could to make sure she was accepted. After all, she had a legacy to carry on. And while her sister encouraged her to have a back-up plan, nothing else really mattered.

But a few months later, Gates was devastated when a rejection letter arrived in the mail. Shocked to her core, the 18-year-old's dreams were dashed in an instant. So much of her identity was tied up in attending Notre Dame that she immediately felt lost and insecure. Suddenly her future was unsure and she no longer knew with clarity just where she was meant to be.

Then came another letter — an acceptance letter from that back-up college which, before she applied, she didn't even know existed. At the top of the letter, she read, "We promise you discovery. The discovery of yourself, the universe, and your place in it."

Those words intrigued her. In fact, they have stuck with her the past 13 years because at Saint Mary's College, Claire Gates found her purpose in life and what she still refers to as *her calling*.

Defining her own path

Her older sister noticed her natural caretaker tendencies and again offered advice. She encouraged her to enter the nursing program. Gates did and thrived. The Saint Mary's environment of small classrooms, access to professors, and most of all, being viewed as an individual in her own right and not as someone's little sister — nurtured her. Here she realized she wasn't meant to follow in the shadows of her older siblings. She was meant to lead.

"I grew intellectually, emotionally, and spiritually over my four years," she said. "I discovered a fire for learning and a deep determination to succeed that I didn't know I had."

That fire endured after graduation as she worked for a few years as a registered nurse and charge nurse but felt compelled to do more. She continued her education, received a master's in nursing, and became a nurse practitioner in 2016.

For a while, Gates worked in internal medicine but realized it didn't fuel her passion. So she made another bold step and took a position with a plastic surgery practice. And for the first time since she started her career in 2009, she knew she had found her true purpose. Happily, she'll tell you she has one of those jobs where she wakes up each morning eager to start the day.


Purpose in her work

Gates works with a plastic and reconstructive surgeon in Chicago where she assists a variety of patients. From a child who sustains a traumatic dog bite to the face or a patient who has developed skin cancer, no day is the same. It's also not what most people expect when you say you work for a plastic surgeon. They typically envision the cosmetic aspects — facelifts, abdominoplasties, and breast augmentations. But Gates said cosmetic surgery is only a small part of what they do.

She is especially appreciative that 65 percent of their patients are women who need breast reconstruction following a mastectomy. This is especially meaningful work to the Saint Mary's alumna who gains purpose from being alongside these women on their journey. For many patients, this is the first time in their cancer journey that a smile finally emerges. "We are the silver lining in their devastating diagnosis. To give them reason to smile again has been unbelievably rewarding and fulfilling and has affected my life in more ways than I can adequately explain," Gates shares.

As for that rejection letter? Gates gratefully realizes that it was a blessing in disguise and that she would not be where she is today without Saint Mary's. Had she gone to Notre Dame and followed in the footsteps of her entire family she doubts she would be a nurse and believes that God put her on this earth to take care of others. "In hindsight," she shares, "I don't like that I considered SMC my back-up school. Saint Mary's deserves to be held in higher regard than that."

Like so many others, Gates found her calling at Saint Mary's and went on to become a successful and confident woman who lives her life with purpose.

"I am forever grateful and owe much of who I am today to the incredible education I received at Saint Mary's," she said. 





My Friend, Katie

On June 13, 2015 I woke up to a dreary, drizzly day. It was moving day for my new husband and me.

I reluctantly plodded up the stairs, where I was immediately intercepted by my mom. I knew the second I saw her. With tears in her eyes she told me the news a mother never fathoms she will have to tell her 28-year-old daughter. My best friend, **Katie Goebel '09**, had passed away. The next few days were a blur. I hurriedly unpacked and shoved boxes into our new apartment, as I also prepared for the arrival of my friends for Katie's funeral.

It was the one reunion we never wanted. I felt that Saint Mary's had prepared us for a lot, but not this. Despite the grief and gut-wrenching heartache of losing my friend, I have been left with something I will forever treasure. A bond forged in Cyber Café, the apartments of Opus, and on the Finny's dance floor. A friendship that is so precious it is deserving of something more profound than the word "friendship." It is a sisterhood.

I met Katie during my first year at Saint Mary's, and it started out as most 19-year-old female friendships do. We both had a love for *The Hills*, *Friends*, and Cyber Café's chicken patty sandwiches, and had organic chemistry together — a class that Katie was always late for despite living two minutes from the Science Hall. I would eventually learn that I had a good 15-minute grace period whenever I was meeting Katie for anything and this tardiness was a Katie quirk I grew to know, love, and simply plan for.

In our junior year we lived kitty corner from one another on the fourth floor of Holy Cross. Apparently, those were not close enough quarters, so we entered the Opus Hall lottery for senior year. As luck would have it, Katie and I got chosen first to live in the coveted apartments.

Senior year was one of the best years of my life. We studied and laughed, and our friend Sarah read us *Twilight* on the Opus balcony. We danced like it was going out of style and ate our weight in pizza rolls. We were months away from entering the real world and reluctant to leave the place that had become our home over the past four years.

We even calculated the failing grades we would need so we could come back for a fifth year. Alas, we were true Saint Mary's overachievers and even if we bombed all the finals in our last semester, we would still have the grades and credits to graduate. We graduated in May of 2009 and made our way out into the world.

Katie and I were both Michiganders so we easily kept in touch after our time at Saint Mary's. We would frequently meet at our favorite pizza place and make a toast to the fact that even though we hadn't figured out how to be adults, we still had each other. Katie would greet me with the best hug and her signature greeting, “Hello, friend,” and if it was Christmas or my birthday, she would come bearing the most thoughtful gift. She was a friend I could tell anything to and she believed in me when I had lost faith in myself. She was my Saint Mary's sister and we were destined to be lifelong friends.

Katie was diagnosed with cancer in the spring of 2015 and passed away just months later. Her diagnosis seemingly came out of nowhere and I wondered, of all the people, why Katie? She loved her family and friends fiercely, was a woman of faith, and the epitome of kindness. The world needed more Katie. I needed more Katie. My last memory of her is one that I will never forget. I got married on June 5, 2015 in Detroit. In the same city, my best friend was lying in a hospital bed fighting for her life. I had asked her almost a year prior to be one of my bridesmaids, but given her illness I knew this was out of the question. Still, Katie was there. Determined, she had persuaded her doctors to sign her discharge papers so she could attend my wedding. Not only did she attend, but she had a gift. Of course, she had a gift! While she was uncharacteristically early, the gesture was classic Katie. This would be one of the last things Katie did. I will always be amazed and humbled by the level of friendship she bestowed on me during the final days of her life.

My 10-year Reunion this summer will be the first time I return to Saint Mary's since losing Katie. Part of me cannot help but think of how empty the campus will feel without her. The other part of me knows that my heart will feel at home surrounded by our memories. Before, I said that Saint Mary's did not prepare me for losing Katie, but perhaps it did. Saint Mary's fosters and celebrates our female friendships, our sisterhoods. These gifts we have been given here are something that not even death can lessen. It will never be OK that I lost Katie, but I will forever be a better person having known and loved her. Katie was the definition of a Belle. And as we all know, once a Belle, always a Belle.

A Starstruck Day with Sutton Foster

I entered a teeming O'Laughlin Auditorium roaring with vigorous energy. I listened as Saint Mary's students, local high schoolers, and community members alike affirmed their excitement for the arrival of Sutton Foster with chatter about how eager they were to see her, a fellow theatre buff like themselves. It was apparent to me, an outsider to the Broadway theatre scene where Foster shines, that a beloved figure was about to enter stage. Being largely unfamiliar with her work and recognizing the energy of the assemblage around me, I felt excluded from some great secret and wanted in.

Foster was invited to Saint Mary's College as the 2019 Margaret Hill Endowed Visiting Artist this spring. She has performed in 11 Broadway productions, played in roles on many TV shows, and even has two albums out. As an established two-time Tony Award winner and current star on the TV Land comedy series *Younger*, Foster's visit to Saint Mary's stirred a lot of excitement on campus in the weeks before her arrival.

While here, she taught a master class and spent the evening answering questions prepared by students and audience members. Foster greeted the enthused audience with a few animated waves. It wasn't until she was well situated on stage that I realized the fullness of Foster's dynamic presence and beaming personality, self-described as being inspired by Carol Burnett from *The Muppet Show*. She revealed to the crowd, “I loved the idea of being a funny lady. That's where the good stuff is — it's fun to play the fool.”

Foster definitely has the sense of humor to accompany such a role, which was apparent during her session on stage when she had the entire crowd laughing at her *Tyrannosaurus rex* impression, including both sound effects and arm movements.

Acting the fool is just one of her talents, though. As a Broadway star, Foster excels at singing and dancing alongside acting, though she confessed that she had a preference for the latter. “Singing without acting is just notes,” she said. “Dancing without acting is just arm movements.”

Her career, which started with dance lessons and play auditions as a girl, blossomed because of the questions that guide her life: *What do I want? What’s in my way? How do I get it?* She was proud of this mentality she created for herself and laughed when she said, “If you want me to do something, tell me not to do it.”

Foster’s personality follows a trifecta similar to her career. Where she enjoys and excels at acting, singing, and dancing, Foster can simultaneously pull off being humorous, serious, and compassionate. I was immediately drawn to her rawness. She showed more of herself with every answer she gave, acknowledging herself as just a person like all of us in the audience. When asked if she was ever starstruck, as certainly many of those in the crowd were, Foster answered, “Of course! I’m constantly starstruck. We’re all just human beings, though.”

It can often be tricky to view celebrities in the same way we view ourselves. In answering her fan’s question in such a vulnerable way, Foster gave the crowd something of herself that we could relate to, exposing the piece of information that we often forget about celebrities — they are just like us. Foster’s radiant authenticity inspired me to view celebrities like herself a little bit differently — gawk at the art they produce rather than at them as people.

Foster further noted that she had even learned something from the Saint Mary’s students who participated in her master class earlier that evening. She told the audience to say yes to opportunities, but confessed that she realized she needed to say yes more herself. “I learned that partly from working with you guys today. You guys inspired me,” Foster had no problem admitting that she, a successful and well-known actress, learns from those whom she inspires daily.

Foster left the women in the audience with an empowering piece of advice, letting them know they can achieve great success just like her. “There is nothing you can’t do that a man can — or even nothing you can’t do better than a man. [As women,] we need to rewrite that story. Don’t limit yourself because the world itself is starting to let go of limitations.”

A Student-Focused, Sustainable Saint Mary's

When Nancy Nekvasil accepted the role as interim president last October, she assumed it in the way she always approached her classroom: focused on the students. When she encountered students at campus events, she was elated to see them, the way that you might hug your best Belle when you haven't seen her in weeks, months, or God-forbid, years. Her face would light up as she reached out for a hug. "I'm a hugger," she always prefaced. But for Nekvasil, it's about more than a gesture of kindness. She truly believes in the power and potential of Saint Mary's women. She wants in her heart for each student to achieve her dreams.

When it came to putting together her strategic priorities through summer 2020, she kept that same laser focus with a realistic lens. *What can I actually accomplish in a little more than a year?* she asked herself. And so she developed "Strength in History, Distinction in the Future" — strategic priorities with actionable goals that honor our strong 175-year history.

She has already overseen the restructuring of Student Academic Services to now include academic advising and the registrar, the Disabilities Resource Office, the Student Success Program, the Career Crossings Office, and Retention and First-Year Experience. These moves came out of hearing from students, faculty, and staff the pain points of having these offices working separately. In its new configuration, staff and administrators are able to address students' academic needs across the board and we as a College are better able to serve the whole student, ensuring Saint Mary's women have the tools they need to succeed.

Inspired by the success of this new structure, she thought about the many other conversations she has had with students, faculty, and staff regarding the needs they see on campus. Through townhall meetings and individual discussions she has learned a great deal about the real challenges and hurdles our students face. A challenge as simple as eating when the dining hall is closed is a need for our students. Work has already started on this, through the creation of a food pantry and support from the Office of Civic and Social Engagement during semester breaks, but Nekvasil recognizes the importance of creating a system that ensures students' basic needs are met.

Hearing that students don't always have access to textbooks, appropriate winter clothing, functional technology, and more has inspired Nekvasil to embrace the following three priorities that will improve the student experience and ensure a Saint Mary's education is accessible for another 175 years. While creating and implementing process and procedure are not entirely exciting endeavors, it is powerful when a student has a study abroad experience that launches her career, or a research opportunity that leads to a breakthrough. It is in these moments of discovery, we see the importance of these worthwhile priorities.



PRIORITY 1: *Enhance student access to a Saint Mary's education*

Everyone deserves the right to an education. Yet, with rising costs of tuition and a competitive atmosphere of college admittance, access to a quality education may seem like more of a privilege than a right to all students seeking a degree. Nekvasil recognizes the need for increased access to a Saint Mary's education through scholarships. She also sees the importance of investing in study abroad opportunities for students, as nearly half of students find this experience to be one of the most transformative of their College career. The development of a strategic enrollment initiative along with increasing funds for scholarships, study abroad, and our summer Embody program for high school girls are key pieces of maintaining a thriving population of Saint Mary's women.




PRIORITY 2: *Foster an environment for academic and personal success*

Support is key to student success and at Saint Mary's, our holistic approach provides an environment for them to thrive. Nekvasil will emphasize academic and personal success for students by increasing funding for student-faculty research; providing support by establishing an Office of Equity, Diversity, and Inclusion; looking critically at which academic programs are beneficial for today's students; providing emergency support for students in need; and establishing a program for first-generation students.



PRIORITY 3: *Strengthen and refine operational practices*

Her third strategic priority is about continuing to provide financial strength, and this, too, Nekvasil sees as a must-have for students. This initiative will review the Master Plan and evaluate academic and student living spaces for renovation needs. Additionally, it will assess the infrastructure of the graduate programs and update our objectives with the continued growth they have experienced over the past three years. The priority also includes the implementation of academic department reorganization to optimize efficiency and foster greater collaborations that allow for development of new and relevant programs.

Ultimately, support, funds raised, and prayers to carry these priorities to fruition will help Nekvasil's short but powerful initiatives maintain focus on our students, our strengths, and our future. 

SISTER ANNA MAE GOLDEN, CSC



Sister Anna Mae Golden, CSC, (formerly Sister M. Joseph Anita), passed away on February 14 at the age of 89. Entering the Sisters of the Holy Cross from Maryland on August 1, 1951, Sister Anna Mae professed her perpetual vows on February 2, 1954.

With mathematics as her strong suit, she earned a master of science in the subject in 1964 from the University of Notre Dame and a doctorate in education in 1981 from the University of Maryland.

In 1972 she came to Saint Mary's College, where she dutifully served over several years in positions related to mission, administration, and strategic planning. Sister Anna Mae was a member of the Board of Trustees from 1994 to 2004 and the Board of Regents from 1976 to 1982 and from 1988 to 1994. During those years, she chaired various committees to develop the pastoral and academic vision of the College. Sister Anna Mae was also the director of admission, the admission counselor for the Rome program, coordinator of institutional planning, and a lecturer in mathematics throughout her time at the College. Sister Anna Mae remained devoted to ensuring that young women receive a quality education during their four years at Saint Mary's College, in the Holy Cross tradition.

Sister Anna Mae's funeral was held on February 21, 2019, at Saint Mary's College, Church of Our Lady of Loretto.

MYRON CLARENCE NOBLE



Myron Clarence Noble passed away on March 22 at the age of 81.

Noble served on the Saint Mary's College Board of Trustees from 1992 to 2004

and on the Parents Council while his daughters Wendy Noble '87 and Heidi Noble '92 were students. He was a

charter member of the President's Circle from 2011 to 2019 and always stepped up when asked for support of the College and other special initiatives.

One of Noble's most charitable gifts to the College includes the Noble Family Dining Hall, where students gather to share meals, study and catch up with fellow Belles. Noble's philanthropy lives on in the South Bend community and at Notre Dame. In fact, memorial contributions were directed to A Rosie Place for Children, the first and only specialty hospital in the state of Indiana exclusively for children who are medically fragile, named in honor of his beloved wife Rosie.

A celebration of life memorial service was held on Saturday, April 20 at Notre Dame Stadium in the Dahnke Ballroom. Friends gathered with the family and shared memories of Myron prior to the memorial service and immediately after over dinner and drinks.

SISTER M. GERTRUDE ANNE OTIS, CSC



Sister M. Gertrude Anne Otis '55, CSC (formerly Gertrude Anne Otis), passed away on February 17 at the age of 96. Entering the Sisters of the Holy Cross from Washington, DC, Sister Gertrude was invested with the holy habit at Saint Mary's College on August 15, 1946, and later made her perpetual profession of vows as a consecrated religious in 1951.

Sister Gertrude received several degrees during her time at Saint Mary's College, including a bachelor's in sacred doctrine (1952), and both a master's in religion (1955) and a doctorate in sacred doctrine (1960) from the School of Sacred Theology.

She served the College as a teacher and administrator during the presidency of Sister M. Madeleva Wolff, CSC . Sister Gertrude worked as registrar from 1950 to 1958, and went to *Pontifical Institute Regina Mundi* in Rome on a sabbatical in 1958. Upon her return to the College in 1959, she served as both the director of admission and dean of the School of Sacred Theology until 1963, taught theology and scripture until 1967, and went on to develop and direct the Tucson Program for Saint Mary's students in Cortaro, Arizona in 1972.

Sister Gertrude was richly gifted by nature, grace, prayer, and faith, and through her service exemplified the mission and ideals of Saint Mary's College.

Just back from Manhattan and a Christmas luncheon that has become an annual event for **Beverly (Barry) Troxler O'Grady, Mary Schuh DeSilva, Joann Vanek**, and me. This year's event took place at Park Avenue South, where the restaurant's menu and ambiance reflect the seasons. Though the silver decorations were breathtaking, it was Joann's friendship with the chef that transformed the festivities as he presented us with delicacies way beyond our individual selections — scrambled eggs on which he grated what seemed a quarter pound of truffles (!) and desserts galore. As Barry emailed afterward: "Still reviewing the tastes and the conversations ... It's good to be loved by the chef!"

Since **Mary Schuh DeSilva** was just back from her 14th hiking trip with two women friends who bonded on their first jaunt, I asked her to send me the full list of where she's been on these trips organized by Country Walkers, based in Vermont. She did so and it's one remarkable list: Sri Lanka this past October and earlier trips to Vietnam, Laos, Cambodia, India, China, Japan, South Africa, Morocco, Bhutan, Turkey, Croatia, and France. Folks are still raving about our 55th Reunion co-chaired again by **Mary Jo Pauli Landry** and **Kathy Wiedl Mettler**. The highpoint was the presentation of the Alumna Achievement Award to **Joann Vanek** for her pioneering work in women's studies as a gender and social statistician, an effort that has led to increasing recognition of women's needs across the world. There is a remarkable through line in Joann's work beginning with her groundbreaking dissertation for her PhD, her university teaching, and then her work in the Division of Statistics at the United Nations where, among other feats, she started an annual report on the status of women throughout the world. Attendees were also treated to a continuation of the discussion started with **Margie Nutting Ralph** at Reunion five years ago, and this time she shared the expanded thinking that has shaped the recently issued paperback edition of *Why the Catholic Church Must Change*. **Mary Rainey** was able to steer the energized

discussion that followed and by all reports it was indeed energized on this round.

A smaller group of Reunion attendees — about 36 (larger than usual for a 55th) — made for richer opportunities to share and enjoy extended conversations, something often precluded when almost a hundred have attended in past years. **Joan Mousaw McGuire (Moose)** recently followed up with a summary of the insights shared at the traditional group discussion session on Saturday afternoon. She and **Judith Ann Reardon (Rudy)** led this event and Joanie organized her follow-up summary around the discussion prompts they'd put before the group. The prompts probed significant memories from our undergraduate years; coping strategies for aging; institutional changes that people have welcomed through the year and those they work hard to resist; and roles or careers people would pursue in their next lives.

On the first prompt regarding salient memories of our earlier years of study, certain faculty were remembered as especially formative influences (the late **Sister Maria Pieta Scott, CSC 1922**, "Charlie B," Bruno Schlesinger, Sister Franzita, and Sister Miriam Patrick). Other memories centered on assigned dinner tables with a Sister of the Holy Cross presiding, episodes of Catholic guilt, mandatory convocations, the experience of growing in faith and appreciating not only a Catholic education rooted in theology and the liturgy, but also the talent in our class and the deepening friendships that have sustained us through the years. On the second prompt that underscored "aging is not for sissies," people shared personal discoveries that work for them: focusing on seeing the glass half full; realizing the necessity for hope and embracing opportunities to practice it; growing comfort in asking for help and seeing that ability as an asset; pursuing lifelong learning; staying active; and confronting the poignancy of illness and dying, as well as valuing the gift of living long enough to appreciate the totality of one's life experience. One participant noted that she thought many people had taken comfort when our own Dr. Mettler spoke of having witnessed the deaths of many people over the years and gradually losing her fear of the process.

Changes that our classmates have welcomed include technology; the expansion of civil rights, most especially a woman's right to equal pay for equal work; medical advances; and changes in the Church. On a negative front, people expressed resistance to the ways technology is impacting and constraining human communications; deterioration of the family unit; the evident decline in civility and literacy; the terrific pace of life; the gap between haves and have nots; and the rapidly increasing narcissism characterizing our society. If they had a second chance, people would gravitate toward new roles and careers, notably as a violinist, harpist, children's author, children's sports instructor, senator, sportscaster, sculptor, activist for underprivileged kids, and engineer.

Our class shared the Reunion Gift Campaign Award with the Class of 1958; both classes have the greatest number of Mother Pauline Society members (13 in each class). Two upperclassmen are funded with our class scholarships in the current academic year and they are deeply grateful for our generosity.

No more news — please send me updates for the next round! Following on the Reunion discussion reported above, if you want to explore more on the issue of civil rights decisions and their impact on our lives as women over the last 50 years, read a wonderfully readable book by Linda Hirshman titled *Sisters in Law: How Sandra Day O'Connor and Ruth Bader Ginsburg Went to the Supreme Court and Changed the World*.
