



Community. It's a simple word that captures the essence of people coming together to serve a common purpose. Whether that be for the College, a social endeavor, or humanity, the essential ingredients remain the same. First, it takes understanding — opening our eyes and ears to the needs and perspectives of others. And it requires a willingness to embrace and celebrate diversity in the pursuit of unity.

This year, Saint Mary's focuses on our core value of Community and it's with this vision we decided to take a look at how the College and three individuals are playing a part in our largest community — that of the world.

The world desperately needs leaders and champions. It needs people who can make connections, nurture relationships, collaborate on solutions, and keep up communications even when a span of latitudes or longitudes lie between.

Saint Mary's supports this belief, through not only our comprehensive study abroad program, but other avenues as well — avenues like Fulbright, the international educational exchange program launched in 1946 and sponsored by the US government. The Fulbright program is complementary to Saint Mary's goals for engaging with others across the globe and working toward creating a better world. College students and faculty have been participating in Fulbright for more than five decades.

For students who achieve Fulbright scholarships, the opportunity to select a country to work within broadens awareness that one person truly can effect change.

For faculty, the relationships they create allow them to build a network of colleagues and mentors in the host country, and to potentially continue their collaborative research thanks to today's technology.

What is my place in this world? What can I do to make a difference?

Receiving a Fulbright Specialist grant, Jamie Wagman, associate professor of history and gender and women's studies, spent three weeks in the African country of Morocco in March. There, she served in an advisory capacity at Rabat International University (RIU), which was founded only nine years ago. Wagman lent her expertise in developing a gender and women's studies master's program at the university. She also advised on curriculum and gave lectures on reproductive justice, transgender rights, visibility, public health history, abortion history and law, and second wave feminism.

Just as importantly, Wagman established networking opportunities that will support research and engage students at both RIU and Saint Mary's on topics such as transnational feminism and Islamic feminism.

Laura Elder understands the power of the Fulbright program. As assistant professor of global studies and Fulbright program advisor at Saint Mary's, she calls Fulbright "a key that opens many doors."

"Literal and figurative doors are opened through Fulbright not only for Saint Mary's students and faculty, but also for the people they meet, work, and live with," Elder said. "When we are exposed to new cultures and ways of living, we are challenged to reflect on our own understandings and to think innovatively."

Fulbrighters address critical global challenges in all disciplines, while building relationships, knowledge, and leadership in support of the long-term interests of the United States. Fulbright alumni have achieved distinction in many fields, including 59 who have been awarded a Nobel Prize, 84 who have received Pulitzer Prizes, and 37 who have served as a head of state or government.

Like Saint Mary's, Fulbright strives to make a significant and lasting impact, both in the foreign country and back home, as participants share stories of their experiences and even engage in follow-up projects or a continuation of the work they started abroad. It creates a multiplier effect, a ripple that can reverberate long and far.

One such ripple will take place over the course of two years as Toni Barstis, professor of chemistry, employs her Fulbright US Scholar Program Award to conduct chemistry research in Nepal and Ghana. In Ghana, she will be working with Sisters of the Holy Cross who operate and minister at a health clinic there. Her research project met with approval from Congregation President Sister Veronique Wiedower '70, CSC, who discussed with Barstis her idea for collaborating with the sisters' missions abroad.

Over the next two years, Barstis will spend three to six months in Ghana sampling and analyzing the pharmaceuticals in the

sisters' clinic to help them detect potentially dangerous fake medicines. Her work will help keep patients safe, leading to healthier communities and productive individuals, now and into the future.

Applying for a Fulbright scholarship or grant is a lengthy process, and it is followed by an extensive waiting period as delegates from both the US and the chosen country review applications.



students and faculty through the application process, she is aware of the similarity between the questions Saint Mary's asks of students and those posed by Fulbright. Saint Mary's encourages students to consider things like, What is my place in this world? What can I do to make a *difference?* With Fulbright, applicants ponder and articulate such questions as, What is your goal? How does that serve the country you want to visit? What can you offer the country?

Eleanor Jones '16 answered those

questions and, as a result, received a Fulbright US Student Program scholarship a year after her graduation. Jones had already spent a year in Pietermaritzburg, South Africa through our foreign study program but felt she still had much to learn about the world, so she applied for the Fulbright scholarship.

The chance to go abroad and learn about new cultures was important to her, and so she chose Mongolia — a place she might not otherwise visit.

In Mongolia, Jones not only taught intermediate English classes to students at the Mongolian State University of Life Sciences in Ulaanbaatar, she participated in several university events in her role as a US cultural ambassador. Jones carries this broader understanding in her current work with VIA Programs in East Java Province, Indonesia. There, she aids in the selection process and edits language content for manuscripts accepted by the Journal of Southeast Asian Human Rights and manages correspondence between researchers and the journal.

Realizing the transformative power of cultural exchange, these individuals — Jamie Wagman, Toni Barstis, and Eleanor Jones - seek mutual understanding, collaboration, and betterment beyond their backyards and hometowns. They are global citizens, creating community through their work, research, and travels. As a result, their impact is amplified, touching the lives of future generations near and far.




# Piecing Together the Puzzle of Alzheimer's By Kathe Brunton

One of the top 10 causes of death in America, Alzheimer's disease is the only one that cannot be prevented, cured, or slowed. It is a major unsolved puzzle in medical research.

But work being done on copper and lead at Saint Mary's College may contribute to the understanding of how Alzheimer's develops, and every little bit of data adds to the growing store of knowledge that many hope may eventually lead to a cure.

### "There's so much we don't know about Alzheimer's and very little that we do." - Kathryn Haas, assistant professor of chemistry



Copper is a naturally occurring metal in the body and essential for life. We obtain it daily through our diets. The brain has one of the highest concentrations of copper in the body, and studies show that people with Alzheimer's have an elevated level of copper in certain parts of the brain. One of the questions driving the research is, are high copper levels a symptom or a cause?

"There's so much we don't know about Alzheimer's and very little that we do," said Haas. "Research to this point indicates that Alzheimer's may be caused by amyloid beta plaques and neurofibrillary tangles. The plaques are made up of tiny pieces of amyloid precursor protein. These pieces normally get cleared away while we sleep. We don't know the purpose; we just know that it happens. But in Alzheimer's patients, the amyloid beta builds up over time and forms plaque that collects in the spaces between brain cells. It's like bits of gunk that clog things up."

In the lab, when amyloid beta pieces are in a test tube, they eventually form plaque. But when copper is added to the mix, plaques are created immediately. "So, the hypothesis is that a relationship exists between copper and the formation of the plaques," Haas said. "If we can understand how this relationship works, we may be able to shed light on a small part of the Alzheimer's mystery."

Haas's research on copper also carries implications for other diseases. Cancer patients, for example, demonstrate higher levels of copper in the blood. A former student in Haas's research group, Madison Sendzik '17, was the first to discover an important interaction between copper and the most abundant protein in the blood, albumin. This incredible discovery by a Saint Mary's student-researcher gives other scientists insight into the effects of copper in the bloodstream.

### A Question of Lead

Another question their research addresses is related to lead. It's common knowledge that even a small amount of lead is toxic, but what is the connection with Alzheimer's? Haas's secondary area of research is based on the hypothesis that exposure to low levels of lead over a long period of time in childhood can lead to Alzheimer's decades later in life.

A study from the 1980s on three groups of monkeys informs some of the research Haas and her students are conducting. One group was not exposed to lead, the second group was exposed in adulthood, and the third group was exposed only in childhood. An unexpected revelation came about 20 years later when the third group began exhibiting signs of dementia. These monkeys were found to have amyloid beta plaques in their brains while the others did not.

When adults are exposed to lead, the effects are treatable and reversable. Not so with children. The difference lies in a person's developmental stage when the genes in our cells are particularly sensitive to the environment. During fetal and childhood development, an enzyme changes which genes are turned "on" and "off" in our cells, in this way telling them what function they are to perform.



Haas's hypothesis is that when lead is introduced into the body at a young age, it interferes with the on-off switching, which leads to an excess of amyloid precursor protein. Again, the protein is broken down into pieces of amyloid beta that group together to form the plaques that are a hallmark of Alzheimer's.

"Exposure to lead, especially during development when this onoff switching happens frequently, combined with time, might explain the occurrence of Alzheimer's later in life," said Haas.

### The Student Impact

Erin Reinhart '15, who worked with Haas as a studentresearcher, discovered that lead sticks to the enzyme that turns genes "on" or "off." It sticks in a way that might interfere with the normal processes and in a way that probably causes it to leave genes "on" too often, genes like the one for amyloid. This research was funded by a Maryjeanne R. Burke and Daughters Pretenure Faculty/Student SISTAR Grant award at Saint Mary's. After she graduated, Reinhart received a graduate research fellowship from the National Science Foundation and is now at Dartmouth pursuing a fully funded PhD in chemistry.

Another student, Jennie Connell '16, followed up on Reinhart's work with research funded by a Marjorie Neuhoff Summer Science Communities grant at Saint Mary's, the same type of grant that funded Sendzik's research. Connell developed a method for detecting whether the enzyme is working. "Now we just need the funding and time to take the next step," Haas said. "We need to find out if the enzyme still works when lead is stuck to it. That will tell us if lead might explain some cases of Alzheimer's disease."

In this research on copper and lead, undergraduates are in collaboration with researchers at other colleges and universities around the country. As she leads, encourages, and supports her students through the scientific discovery process, Haas is hopeful that their findings may help other scientists in the continued quest to illuminate the causes and processes of not only Alzheimer's but other disease states as well.

"I have lived in the beauty of the Northern California foothills since 2000. My family and I had moved into our dream home in September 2017, after 17 years of roughing it in an older farm home in Paradise, CA. We were finally beginning to feel some fruit of our labors of love for the past 18 years, when the Fire of November 8, 2018 came. That day, I sat in stalled evacuation traffic while the town burned in front, behind, and alongside me for 3½ hours. traveling a mere five miles at a time. I was separated from Evelyn, my 12-year-old daughter, whom I had just dropped off at school. She evacuated safely to Chico with a school teacher. My 17-year-old daughter Julia was out of town, safe from the flames that consumed her cherished memories of her deceased father and her childhood.

In 2013, I had expanded my home-based practice of 12 years and opened an alternative and holistic healing center called O'Hana Health, serving local communities with compassion, offering many affordable services such as massage therapy (my passion), acupuncture, and yoga classes. Within hours of the fire, all of it was gone.

"We are blessed to have friends who opened their home to me, Evelyn, and Julia for months. To buy a home in nearby towns like Chico requires \$100K over the asking price. If you ask us, we will tell you we just want to go home. Evelyn and I are now in Kaui near my brother and his family, and Julia is staying with friends in California finishing up her senior year of high school. I applied for Red Cross help and find myself dealing with the trauma in small doses. If you feel called to help, send gift cards. Most of the millions being donated is not getting to the people who need it.

Through all of this I've been a witness to kindness, generosity, and compassion most of the time. And, I get to be ... grateful, practice acceptance, and remember that I live in abundance and serve a big God."

We are all on singular journeys, in many places around the globe, but our time at Saint Mary's



connects us in important ways. My heartfelt thoughts and prayers go out to all who are struggling in some way and all classmates who have lost parents recently. Perhaps we can keep one another close in prayer and thought as a body of '85ers.
