# **Curriculum Policies and Guidelines**

### Acceptance / Progression into the Major

The BSN curriculum includes four years of study designed to provide the student with a found-a-tion in the liberal arts as well as the knowledge and skills needed to function as a professional nurse upon graduation. Liberal arts courses are prerequisite to or concurrent with the pro--fessional studies and are arranged so that these two components are mutually supportive.

Students may be accepted to Saint Mary's College either as a nursing major "direct admit" or "intended nursing major." Regardless of admission status, criteria for progression into the NURS courses in the second semester of the sophomore year include a cumulative GPA of 2.8 and a prerequisite science GPA of 2.8. Course grades for BIO 141 Human Anatomy and Physiology I, BIO 142 Human Anatomy and Physiology II, BIO 216 Introduction to Microbiology, BIO 224 Introduction to Pathophysiology, and CHEM 118 Integrated General, Organic and Biochemistry are included in this calculation. All required science courses for the nursing major must be taken at Saint Mary's College. Transfer students will be evaluated on an individual basis.

Intended nursing majors (those students who are not nursing major direct admits) must petition for admission to the nursing major during the fall of the sophomore year and complete a major declaration form that is found on the Student Academics tab of the my.saintmarys.edu portal. The completed form must be submitted to the Department of Nursing Science office. Formal admission occurs after the student's cumulative GPA and prerequisite science GPA have been calculated after final grades are posted. Students will receive written notification of formal acceptance into the nursing major. Students who wish to transfer from other nursing programs must meet the standards required for regularly enrolled students. Only students who are admitted to the nursing major may take NURS courses.

Students may study abroad during the fall semester of sophomore year (or during the summer). Those who intend to study abroad in the fall must take BIO 224 Introduction to Pathophysiology and BIO 216 Introduction to Microbiology in the summer prior to departure. These summer courses are only offered for study abroad students, students needing to retake a course, and students intending to apply to the MSN program.

### Repeated Courses Policy for Admission or Progression into the Major

- 1. All science prerequisites must be taken at Saint Mary's College. This means completing the course and receiving a letter grade. A course does not count as being taken at Saint Mary's College if the student withdraws from the course or fails the course. (This policy does not apply to transfer students.)
- 2. A student may retake a maximum of 2 prerequisite science courses in which the student earned a grade below B (3.0) to raise her science GPA in order to progress

into the second-semester sophomore year courses. All attempts are figured into the GPA requirement. It is preferred that the courses are retaken at Saint Mary's College; courses not taken at Saint Mary's College will not count toward the pre-requisite GPA.

3. Students must earn a C or higher in BIO 141 Human Anatomy and Physiology I and BIO 142 Human Anatomy and Physiology II in order to progress into the NURS classes second semester of the sophomore year.

For students admitted prior to 2022, course retakes are grade replaced for the science GPA but averaged into the cumulative GPA. For students admitted in 2022 and thereafter, cumulative and science prerequisite GPAs are calculated based on all course attempts. The Department of Nursing Science does not round cumulative or prerequisite GPAs for the purposes of admission to the major. Per College policy, a student cannot earn credit hours twice for a repeated course.

#### **Essential Abilities**

The American Nurses Association Code of Ethics calls for competent and ethical care of patients and charges nurse educators to ensure that the skills of the nurse or nursing student are appropriate in order to provide safe nursing care to assigned patients. Patient and student safety are a priority for the faculty of the Department of Nursing Science.

For a student to be admitted to any of the nursing programs at Saint Mary's College, the student must:

- 1. Meet all prerequisite admission standards as defined by the College and the Department of Nursing Science.
- 2. Be able to demonstrate the essential abilities for participation in the nursing program with or without reasonable accommodation.

Title Three of the Americans with Disabilities Act prohibits discrimination of a "qualified individual with a disability." Title Three defines disability as "a physical or mental impairment that substantially limits one or more major life activities of (an) individual." A qualified individual with a disability is defined as an individual who, with or without reasonable accommodations, meets the essential eligibility requirements for participation in a program.

There are skills and attributes that the faculty of Saint Mary's College Department of Nursing Science have determined as essential to safe nursing care. These Essential Abilities apply to all students in the undergraduate and graduate nursing programs.

#### Attendance

Regular attendance in all classroom and clinical experiences serves as the foundation for learning to provide safe nursing care.

Essential Physical and Environmental Abilities

The nursing student:

- Is able to fully and safely function in an environment that may have allergens; infectious and/or communicable diseases; and chemicals.
- Has fine motor control, hand-eye coordination, physical health, and stamina to perform
  necessary nursing skills consistent with the scope of practice. This may include, but is
  not limited to safely preparing and administering medications; lifting, bending, twisting;
  pushing and pulling patients and equipment; performing CPR (move patient, perform
  chest compressions, manually ventilate the patient), walking and standing for prolonged
  periods; working 8- to 12-hour shifts.

#### **Essential Communication Abilities**

#### The nursing student:

Has the sensory skills to interact appropriately and communicate effectively with patients from diverse backgrounds. This includes verbal, nonverbal, and written abilities, including the use of computing and information technology. The student must be able to communicate effectively and spontaneously, verbally and in writing, with fellow students, faculty, patients, and all members of the health care team.

#### Essential Intellectual/Cognitive Abilities:

#### The nursing student:

Must be able to identify, assess, and comprehend conditions surrounding patient situations in such a manner that the student is able to derive appropriate conclusions. Must be able to use subjective and objective data to appropriately problem solve and develop a competent and safe course of action consistent with the student's level of education. This includes having math computational skills, and the ability to reason, measure, calculate, analyze, synthesize, and evaluate situations to competently engage in safe nursing care.

#### **Essential Sensory Abilities**

At a functional level that allows the nursing student to perform required clinical skills, with or without accommodations, has the ability to use the senses of vision, touch, hearing, and smell to safely assess and provide care for patients. This includes but is not limited to:

- Vision: Ability to gather visual information about the patient and environment; see well enough to read all materials related to classroom work and patient care.
- Touch: Ability to interpret information gained through touch during a physical assessment which includes but is not limited to differentiation of textures, density, and vibration.
- Hearing: Ability to accurately hear conversation spoken in usual conversational tone and calls for help if not in a patient room; able to engage in telephone conversations; detect normal and abnormal body sounds (including subtle high and low-frequency sounds) through a stethoscope; hear all alarms emitted by monitoring and other equipment.
- Smell: Ability to detect odors exhibited by bodily functions and fluids that may indicate infectious, emergent conditions, or other disease states; and environmental smells such as smoke or natural gas.

#### Essential Behavioral/Emotional Health Abilities

#### The nursing student:

Must possess the emotional health required to make safe and appropriate clinical judgments. Must function effectively in stressful situations and adapt to an environment that changes rapidly and often in unpredictable ways without warning, and respond to emergencies with precise and prompt actions. Students must adhere to the College policy regarding addiction and substance impairment when in the classroom and clinical setting.

#### **Essential Ethical Abilities**

#### The nursing student:

Must adhere to legal, ethical, and moral standards within the scope of nursing practice; demonstrate honesty and integrity in all interactions within the classroom, clinical, and community settings. Must demonstrate accountability and responsibility in all classroom and clinical situations. Provide care that is compassionate, respectful, non-judgmental, dignified, and altruistic for individuals, families, and communities. Students must be able to reason morally and practice nursing in a legal and ethical manner.

#### **Essential Judgment Abilities**

#### The nursing student:

Must be able to gather, evaluate, and apply information and engage in critical thinking in the classroom, clinical, and research settings. Students must be able to prioritize workload demands and patient findings in usual and emergent conditions in order to provide safe and effective care.

#### Essential Abilities Procedure

- 1. Essential Abilities criteria will be provided on the Saint Mary's College Department of Nursing Sciences website and to all students.
- 2. Students admitted to Saint Mary's College nursing programs and applicants who accept an offer of admission to any of the Saint Mary's College nursing programs must sign a letter of agreement that indicates the student has read and understands that the ability to meet the Essential Abilities criteria, with or without reasonable accommodations, is a requirement. Students who question their ability to meet the criteria should contact the Accessibility Resource Office (ARO).
- 3. Title Three of the Americans with Disabilities Act prohibits faculty from asking about disabilities. It is the student's responsibility to contact the ARO for help with accommodations and to comply with the policies and procedures of the ARO.
- 4. Accommodations become effective on the date requested by the ARO and are not retroactive.
- Accommodations beyond those determined by the ARO are not permitted.
- 6. Faculty are responsible to determine whether a student demonstrates the Essential Abilities criteria. Faculty may request a consultation from recognized experts as deemed appropriate. Students are responsible for the cost of all consultations.

- 7. Students who do not meet the Essential Abilities criteria, with or without reasonable accommodations, at any point in their academic program may have their progress interrupted until they have demonstrated their ability to meet Essential Abilities within a specified timeframe.
- 8. A student who is unable to meet the Essential Ability criteria, with or without reasonable accommodations, shall be dismissed from the program.
- A student who is dismissed based on the inability to demonstrate these Essential
  Abilities criteria may appeal the decision in accordance with the Saint Mary's College
  appeals policy.

#### Progression in the Major

In order to progress through the major students must pass all nursing courses (N225, N227, N307, N310, N321, N323, N330, N334, N385, N410, N414, N415 and N426) with a grade of C (76%) or better; satisfactorily pass the clinical component of the course; and complete all prerequisites. Satisfactory clinical performance includes successful completion of all critical behaviors and satisfactory completion of the objectives in the clinical evaluation tool. Unsatisfactory clinical performance will result in an overall grade no higher than C- for the course. A student may repeat a nursing course only one time in which the student has been unsuccessful. Two failures in one course or two separate nursing courses will constitute dismissal from the program.

If a nursing student must repeat a nursing course, progression in the major is based on the availability of the course, the availability of slots in the clinical setting, and appropriate nursing faculty coverage. When a student is "out of normal progression," the student cannot displace a student who is progressing according to the curricular plan.

After the 5 week drop period, a student may withdraw from a course with the permission of the Student Academic Services Office and the instructor of the course or on the recommendation of a physician for health reasons up until the Friday after midterm break. If the student is passing the course at the time of withdrawal, or if the student withdraws from all classes upon recommendation of a physician for reasons of health, the grade of "W" is recorded. If the student is failing the course at the time of withdrawal, or withdraws without permission, a grade of "F" is recorded. Students who withdraw using a medical leave will be considered out of sequence, and will require an additional semester to complete the requirements of the nursing major.

The minimum passing grade in the nursing major is a C. All scores achieved are absolute, and grades are not rounded; for example, a grade of 75.9999 will not be rounded to 76. Students with grades below 76.0% at midterm will receive a deficiency notice.

**Please Note:** Most NURS courses require students to achieve an average exam grade of 76% (C or above) on all theory exams, including the final exam. A theory exam average of less than 76% constitutes course failure. Non-exam scores are only added to the student's grade after this requirement has been met. If the student does not achieve an exam average of 76%, the maximum grade reported will be a C-, regardless of the overall course points earned. This requirement will be stated in the course syllabus when applicable to the course.

If a student fails clinical (receives an unsatisfactory non-passing rating on the clinical evaluation), this is considered an automatic course failure and the highest grade the student can earn for the course is a C-. The student may choose to continue to attend lectures, but will not be allowed to take course exams.

The "student success plan" is a form used to address and document any areas of concern, including an exam grade average below 76% or individual exam grades below 76%. Based on the severity of the concern, nursing faculty may choose to institute a probationary learning contract.

A grade of incomplete is used to respond to a crisis that impairs a student's ability to finish a semester that they have otherwise been progressing in throughout the semester. A student must have completed at least 70% of the work in this course and must have demonstrated the ability to complete the coursework independently within the first 30 days of the following semester. If the coursework is not completed within the first 30 days of the following semester, a grade of F will be assigned.

A faculty member may not assign an incomplete grade to a student who:

- has not completed 70% of the work or
- has not made satisfactory progress during the semester.

Depending on prerequisite requirements, a student granted an incomplete in this course may not be able to progress to courses in the subsequent semester, resulting in delayed graduation. It is the student's responsibility to investigate the financial ramifications of an incomplete grade.

### **Nursing Exam Policy**

Exams are weighted as stated in the course syllabus. Every course exam has at least three questions from the assigned readings, covering content not discussed in class.

Students are expected to abide by the Department of Nursing Science test-taking policy. Inability to follow these rules or any suspicious behavior will result in stopping the exam immediately; the student may receive a grade of zero (0) on the exam.

#### On Exam Days:

- Arrive early to class.
- Turn off phones and remove smartwatches, placing them in your backpack.
- Place non-testing items (backpacks, cellphones, smartwatches, water bottles, etc.) at
  the front of the classroom before starting the exam. Textbooks, notes, calculators,
  or any other resource are prohibited unless specified by the instructor. It is up to the
  faculty member to determine whether the student may use a calculator during the
  exam.
- During the exam and at the discretion of each faculty member, students may have one piece of blank paper and a pen or pencil. This piece of paper must contain the student's name and be turned in to the faculty member when the student finishes the exam.
- Baseball caps and/or hoodies are prohibited during testing. Sleeves must be pulled up, and the faculty member must confirm that nothing is written on the student's arms.
- Communication (verbally or nonverbally) with other students is prohibited while testing. Students must keep their gaze forward, focusing on their exam/computer screen.
- A student cannot leave the classroom after the exam has been distributed or started. If a student leaves the classroom, the student will not be allowed to resume the exam.
- Students are not allowed to ask questions or to clarify the meaning of words during an exam.
- Faculty members may walk around the classroom or designate specific seating during exams for closer monitoring.
- Exams are not returned to students.

#### Review of Exams:

 After the exam has been graded, students will be provided an opportunity to review the exam questions.

- At no time will faculty engage with a student in a debate about test questions during exam reviews.
- Questions and concerns should be brought up directly to the faculty member in a timely fashion and civil manner.
- If a student would like to challenge an answer on an exam, the student must submit evidence that supports the proposed answer choice within 7 business days of taking the exam.
- The supporting evidence must come from the required and recommended course material. The response is to be typed (in APA format with citations) and must be submitted within 3 business days from the exam review date.
- The faculty member holds the final authority to award credit, and how many points will be awarded, to students who have provided a valid rationale for their answers.

#### **NURS Course Grade Appeal**

When a student believes that a final course grade is unjustified, the student must first discuss the grade with the course's professor. If the student and instructor cannot resolve the issue, the student may consider a formal appeal of the grade. An error in grading procedures or inequity in the application of the policies stated in the course syllabus are grounds for an appeal. A disagreement with the professional judgment of the professor is not the basis of an appeal and will not result in a change of grade.

If, after consulting with her professor, the student believes there is reason for an appeal of her final grade, the student may make a formal written appeal to the Admission, Progression, and Graduation (APG) committee. The following components should be addressed in the written appeal:

- 1. A brief summary of the conversation with the professor.
- 2. The grounds for the appeal must address an error in grading procedures or inequity in the application of policies stated in the course syllabus.
- 3. Documentation that supports claims of a grading error or inequities.

Due to issues with program progression, the student should email the appeal to the Admission, Progression, and Graduation (APG) committee (smcapg@saintmarys.edu) within 7 business days of the due date for final grades. Appeals submitted beyond 7 days will not be considered. Once the APG committee reviews the appeal, the student will receive a decision within 7 days. If the student is unsatisfied with the appeal decision, the student may submit a second appeal within 7 days to the Director of Nursing Science, addressing the same points as above. The director will review the appeal within 5 business days and issue a decision. If the student wishes to appeal that director's decision, the student must then submit the appeal to the Dean of Student Academic Services.

#### **Acceptance of Transfer Students**

Transfer students may be accepted on a case-by-case basis, depending on availability. The Office of Student Academic Services or the appropriate department will review courses taken at other colleges or universities for transfer credit.

#### Dismissal

The Department of Nursing Science reserves the right to dismiss any student from the major whose personal integrity, academic performance, or conduct demonstrates unprofessional behavior. Please refer to the Policy on Academic and Clinical Performance. Professional behavior standards are based on The American Nurses Association Code of Ethics for Nurses: Interpretation and Application (2008). Dismissal is subject to the appeal procedure (see College Bulletin).

#### **Program Dismissal Appeal**

A student has the right to appeal a dismissal. A student may appeal a dismissal if the student has new substantive information not considered at the time of the dismissal. Her written appeal must include this new information and a plan for future success. The following components should be addressed in the written appeal:

- 1. Details of any extenuating circumstances that led to the low grade(s).
- 2. An action-oriented, logical plan for success if the appeal is accepted.

Due to issues with program progression, the student should email the appeal to the Admission, Progression, and Graduation (APG) committee (smcapg@saintmarys.edu) within 7 business days of the due date for final grades. Appeals submitted beyond 7 days will not be considered. Once the APG committee reviews the appeal, the student will receive a decision within 7 days. If the student is unsatisfied with the appeal decision, the student may submit a second appeal within 7 days to the Director of Nursing Science, addressing the same points as above. The director will review the appeal within 5 business days and issue a decision. If the student wishes to appeal that director's decision, the student must then submit the appeal to the Dean of Student Academic Services.

#### Students with Disabilities

If you have had documented academic adjustments (accommodations) in the past and/or think you may be eligible for them presently, you should contact the Accessibility Resource Office (ARO) at <a href="mailto:aro@saintmarys.edu">aro@saintmarys.edu</a> to make an appointment to discuss this matter. The ARO is responsible for coordinating academic accommodations for students each semester and they will issue a letter of documentation for the current semester. Please note that academic accommodations are not retroactive; requests for accommodations will be honored once the student notifies the faculty member of the official letter of documentation issued by the ARO and meets with the faculty member to discuss it. Securing reasonable accommodations requires timely action on the part of the student.

#### The Writing and Tutoring Center

Tutors are available to help with Nursing course tutoring sessions and with APA writing style. The Department of Nursing Science requires the use of APA style 7th edition for all papers. #### **Library Resources**

EBSCOHOST Research offers full-text access to journals in the health and behavioral sciences, plus access to the Cochran Databases and International Pharmaceutical Abstracts. CINAHL, PUBMED, and EBSCOHOST Research are available from the Cushwa-Leighton Library home page.

The health sciences library liaison is available to help with APA style, references, article searches, and access to sources. Students are highly encouraged to meet with the librarian during this course; please contact the librarian directly to schedule an appointment. ### **Advanced Writing Proficiency Policy**

Advanced Writing (W) Proficiency is a measure of proficiency in writing and is evaluated within the nursing major during the senior year. A paper is submitted for review and is evaluated for demonstration of professional writing proficiency within the discipline of nursing. The Department of Nursing Science requires the use of the current style manual of the American Psychological Association for all course assignments as well as the Advanced W proficiency paper.

Nursing majors who are taking 400-level nursing courses during an academic year (fall or spring semester) will register for NURS 998 Advanced W Proficiency in the fall semester. Students are expected to achieve a grade of "pass" during the fall semester. Criteria for the assignment are distributed in the Spring of Junior year.

To pass the Nursing Advanced W proficiency paper, students must meet the passing criteria outlined in the grading rubric by the end of the fall semester. The student's final grade will be recorded in Banner as pass/fail and reported in Blackboard as a score (per rubric). Students who do not receive a "pass" will be given an "incomplete" for the Advanced W and have 30 days after the beginning of the spring semester to replace the "incomplete" with a "pass." Failing to do so results in the student being a degree candidate.

#### **Comprehensive Examination**

Satisfactory completion of a comprehensive examination is required for all nursing majors. The Comprehensive Exam is administered in the student's final semester of the program. The Comprehensive Exam is a computerized exam that is predictive of performance on the NCLEX-RN. The student will be required to meet a set of criteria before taking the Comprehensive Exam. Additional information regarding the Comprehensive exam will be provided to the student at the beginning of their final semester.

#### **Standardized Testing Policy**

Standardized tests utilizing Kaplan's testing platform are administered throughout the BSN curriculum. These exams are similar to the NCLEX-RN licensure examination, and scores are compared with national norms. Integrated (secured) exams are given at the end of NURS 225, NURS 227, NURS 307, NURS 310, NURS 321, NURS 323, NURS 330, NURS 334, NURS 385, NURS 410, NURS 414, NURS 415, and NURS 426. Each integrated Kaplan exam has individualized grading criteria based on a percentile rank that determines each course grade, based on achievement of the 50th percentile for normed exams. The Kaplan exam is worth 4% of the total course grade.

Remediation of missed questions is required. In order for the Kaplan system to capture that remediation was completed, a student must review all questions for a minimum of one minute, understanding that purposeful and effective remediation may require more time. A review of correct questions could strengthen knowledge, especially for those questions for which the correct answer was a guess or for which the student had only partial understanding. Review of incorrect questions and the implementation of remediation strategies could decrease knowledge gaps, correct thinking, promote and strengthen concept connection, and build clinical judgment within the NCLEX Client Need Categories. In addition to the proctored integrated tests, students have access to additional study materials and focused review tests.

### Independent Study (NURS 497)

Interested students should contact the professor with whom they wish to conduct the independent study. If the faculty member agrees to participate, the student and faculty member determine the objectives, evaluative criteria, and the number of credit hours to be earned (1-2 credits). Credits should not exceed 2 credit hours per semester. The faculty will decide the number of hours and work required to meet the objectives developed by the student. The faculty member and student complete a Learning Contract. The student is responsible for obtaining the signature of the Department Chair and for submitting the contract to the Office of the Registrar. The Learning Contract must be received by the Office of the Registrar no later than the 7th day of the semester.

# **Student Responsibilities**

#### **Academic Honesty**

Students are required to abide by the College's Statement on Academic Honesty and Plagiarism. In addition, students are required to comply with the Department of Nursing Science Plagiarism Policy and <u>Honor Code</u>.

Plagiarism is copying another person's work and passing the copied material as your own work without giving proper credit to the original author. Plagiarism is considered fraud and will not be tolerated. The professor reserves the right to submit students' writings through a plagiarism checker. The first instance of plagiarism will result in a zero for the assignment and a probationary contract placed in the student's permanent file with the Dean of Academic Services office. A second infraction will result in a course failure, and may also result in dismissal from the program.

If academic dishonesty occurs, the first instance will result in a zero for the assignment or exam, and a probationary contract will be placed in the student's permanent file with the Dean of Academic Services office. A second infraction will result in a course failure and may result in dismissal from the program.

#### **Attendance Policy**

The Department of Nursing Science abides by the College's attendance and absence policy related to classroom attendance noted in the College's Bulletin.

"Saint Mary's College remains committed to and centered on an in-person campus in the classroom and beyond. Hyflex options (streaming an in-person course for students who are not physically in class) should only be offered in cases of illness or emergency and only when a faculty member determines that a class can be offered in a way that supports the learning of students both in the classroom and those attending online. Faculty may request documentation in order for a student to attend a class online and may consult with Academic Advising regarding this documentation.

In no case will faculty members at Saint Mary's College offer hyflex access to a student for an entire semester as an accommodation. In cases of poor weather, adverse travel conditions, and/or other need for the College to close during a scheduled class day, instructors are encouraged to move affected classes online and may require students to participate at the scheduled course time or asynchronously." (Saint Mary's College Hyflex Covid Policy, August 2023).

### Class/Lecture Attendance

Class attendance is a demonstration of professional behavior. If a student cannot attend a class, the student is expected to notify the faculty (via college email, text, or voicemail) a minimum of

30 minutes before the start of class; however, this notification does not mean the absence is excused. Excused absences are granted by the Office of the Dean of Students for illness verified by documentation or college-sponsored activities (such as athletics, choir, etc). It is the student's responsibility to obtain the information presented in the lecture the student missed. Repeated absences or episodes of tardiness will result in a <u>probationary learning contract</u> and potential course failure. Students may not miss class/clinical/seminar/labs for travel prior to or after holidays; such absences are considered unexcused.

### Clinical/Laboratory/Seminar Expectations

- Students are required to complete all clinical hours, including seminars, simulations, and observations.
- Students are expected to meet the "essential abilities" and expectations of
  professional behavior as outlined in the student handbook for the clinical
  experience. Failure to meet these will result in a <u>probationary learning contract</u>, and
  the student will be at risk of receiving an unsatisfactory rating for the clinical
  experience.
- The student's clinical performance will be evaluated by the faculty member teaching the clinical component of the course. Evaluation of clinical performance is based on the learning outcomes of the course and the Clinical Evaluation Tool available in Typhon.
- The student must achieve a satisfactory (S) or accomplished (A) clinical performance rating and demonstrate safe and competent care to pass the clinical component of the course.
- A student who does not receive an (S) or an (A) for every clinical outcome statement on the clinical evaluation will not pass the clinical and will receive a final course grade no higher than a C-.
- Any student who falsifies clinical attendance, clinical documentation, or clinical paperwork (including information documented in Typhon) will fail the clinical and fail the course (receive an F grade).
- If the student fails the didactic portion of the course and passes the clinical component, the student must repeat the clinical component of the course when the student retakes the course.
- Students who do not complete the required 84 hours of clinical or do not complete all required clinical assignments will receive an unsatisfactory rating and fail the clinical unless the student makes up the hours missed by the end of the semester.
- Clinical hours make up is subject to clinical facility approval and the availability of clinical faculty, and will incur additional costs to the student. Clinical make up is not guaranteed.
- Students who are feeling ill should not attend clinical, including but not limited to
  experiencing the following symptoms: fever, productive cough, vomiting, diarrhea,
  open sores, etc. If a student comes to clinical ill or becomes ill during clinical, the
  student will be sent home and will be required to make up the missed hours.

- Students who arrive unprepared for clinical or arrive late to clinical may be sent home by the instructor. The student will be required to make up the time missed.
- The student must be making satisfactory progress toward course competencies before the clinical makeup is considered. If a student is unable to meet all required clinical hours, the student will receive a failing grade for the course.
- In certain situations, the student may qualify to receive an incomplete grade for the course, which will still require making up any hours of missed clinical time within the timeframe established by the incomplete grade policy.

#### **Professional Behavior**

Expectations of professional behavior are found in the syllabus for each clinical course. Students must demonstrate professional behavior in order to progress in the major and maintain professional conduct while in uniform outside the clinical setting.

#### Use of Cell Phones

The non-emergency use of cell phones is prohibited in the classroom, laboratory, seminar, and clinical settings. Students who have an emergency that requires the use of a cell phone must notify the faculty member.

Students may not take photographs inside of healthcare facilities, which includes photographs of patient information, patients and patient families, staff, student colleagues, or selfies.

#### Social Media

The following guidelines are intended to minimize the risks of using social media:

- First and foremost, nurses must recognize that they have an ethical and legal obligation to maintain patient privacy and confidentiality at all times.
- Nurses are strictly prohibited from transmitting by way of any electronic media any
  patient-related image. In addition, nurses are restricted from transmitting any
  information that may be reasonably anticipated to violate patient rights to
  confidentiality or privacy, or otherwise degrade or embarrass the patient.
- Do not share, post or otherwise disseminate any information, including images, about a
  patient or information gained in the nurse-patient relationship with anyone unless there
  is a patient care related need to disclose the information or other legal obligation to do
  so.
- Do not identify patients by name or post or publish information that may lead to the identification of a patient. Limiting access to postings through privacy settings is not sufficient to ensure privacy.
- Do not refer to patients in a disparaging manner, even if the patient is not identified.
- Do not take photos or videos of patients on personal devices, including cell phones.
   Follow employer policies for taking photographs or video of patients for treatment or other legitimate purposes using employer-provided devices.

- Maintain professional boundaries in the use of electronic media. Like in-person relationships, the nurse has the obligation to establish, communicate and enforce professional boundaries with patients in the online environment. Use caution when having online social contact with patients or former patients. Online contact with patients or former patients blurs the distinction between a professional and personal relationship. The fact that a patient may initiate contact with the nurse does not permit the nurse to engage in a personal relationship with the patient.
- Consult employer policies or an appropriate leader within the organization for guidance regarding work related postings.
- Promptly report any identified breach of confidentiality or privacy.
- Be aware of and comply with employer policies regarding the use of employer-owned computers, cameras, other electronic devices, and use of personal devices in the workplace.
- Do not make disparaging remarks about employers or co-workers. Do not make threatening, harassing, profane, obscene, sexually explicit, racially derogatory, homophobic, or other offensive comments.
- Do not post content or otherwise speak on behalf of the employer unless authorized to do so and follow all applicable policies of the employer.

# **Student Screening Policies**

### Student Impairment and Criminal Background Disclosure

The Joint Commission, the accrediting body for hospitals, requires a background check and drug test on all students working in hospitals. Background checks and drug tests are purchased through CastleBranch at castlebranch.com.

Any evidence of impairment due to such factors as sleep deprivation or the effects of medications (prescribed or non-prescribed) is not in keeping with professional behavior.

The ANA Guide to the Code of Ethics for Nurses: Interpretation and Application states, "Nurses must be vigilant to protect the patient, the public and the profession from potential harm when a colleague's practice, in any setting, appears to be impaired" (ANA, 2008, p. 155). In addition, the faculty abides by the ANA Scope and Standards of Practice, which states that "the registered nurse takes appropriate action regarding instances of illegal, unethical, or inappropriate behavior that can endanger or jeopardize the best interests of the healthcare consumer or situation" (ANA, 2010, p. 47).

If a student presents to clinical with any evidence of impairment, the student will be immediately required to submit for substance abuse testing. The faculty or staff member who suspects impairment will request that the student immediately leave the clinical area while

ensuring the student's safety. This means that the student may not drive herself away from the facility and must make arrangements for a cab. The faculty member will determine the most appropriate testing location. The student is responsible for receiving immediate testing and bears the costs involved with transportation to and from a testing facility and the testing itself. The testing may involve all of the following: urine, blood, and hair follicle testing. Refusal to submit to testing will be considered a positive test and will result in failure of the course and program dismissal.

In addition, students must abide by the Saint Mary's College Drug Policy found in the Saint Mary's College Student Handbook.

#### **Drug Screening**

To provide a safe working environment, area hospitals, and other clinical agencies require that individuals who provide care to patients undergo drug testing. Students are required to have a minimum 9-panel drug screen as a condition for participating in clinicals. The student is responsible for the cost of the drug screening.

Student admission to the nursing program is contingent upon drug screen results that demonstrate no evidence of illicit drug use. Students who test positive for a drug specifically prescribed for a medical condition (e.g., ADHD) must submit documentation from the healthcare prescriber that includes the name of the drug, the dosing schedule, and the reason for the prescribed medication. Positive drug tests must undergo examination by the Medical Review Officer (MRO) for the testing company. Students who do not receive MRO clearance will be denied entry to the major.

### Criminal Background Check

Criminal history background checks are required of all nursing students in compliance with state and federal (House Bill 1633) regulations for individuals in clinical settings and when working with patients or individuals who are minors or vulnerable. All clinical agencies require a criminal background check. Additionally, past criminal history may have a negative impact on a nursing graduate's ability to obtain a license to practice nursing. In most states, individuals who have been convicted of certain crimes may not be employed as a Registered Nurse, operate a home health facility, or work in the public school system. It is the student's responsibility to investigate the laws governing licensure in their state of residence for eligibility.

Students must submit a criminal background history check as a condition of admission into the nursing program. The student is responsible for the cost of the criminal background check. Further, students will be asked to complete a Criminal History Disclosure Statement Form on an annual basis. The student is responsible for reporting any criminal arrest or situation (including operating while impaired-OWI) which occurs during the academic year to the Director of the Nursing program before the next clinical day.

Violation of the above policies may subject the individual to disciplinary action up to and including dismissal from the program.

# **Health Requirements**

The following immunizations are required by Saint Mary's College: URL <a href="https://www.saintmarys.edu/student-life/student-services/vaccine-policy">https://www.saintmarys.edu/student-life/student-services/vaccine-policy</a>

To participate in clinicals, nursing majors must provide additional health documentation required by affiliated clinical agencies to the Department of Nursing Science. Students who fail to submit all required documentation will not be permitted to attend clinical experiences and are subject to course failure. All required forms must be uploaded to the student's Typhon account.

### **Physical Examination**

Before entry into Sophomore year nursing courses, a <u>physical examination</u> by a licensed healthcare provider is required. Students should make their own arrangements for this exam either through their family healthcare provider or through Health and Wellness Services at Saint Mary's College. Please note that Health and Wellness Services will do the physicals for nursing students free of charge.

#### **Tuberculin Test IGRA Policy**

- The Department of Nursing Science and health care systems require students to be tested for tuberculosis (TB) prior to attending any clinical experiences. The two <u>Interferon Gamma Release Assay (IGRA) blood tests</u> that have been approved by the U.S. Food and Drug Administration (FDA) to test for TB infection are the
  - a. QuantiFERON®-TB Gold In-Tube test (QFT-GIT) and the
  - b. T-SPOT TB® test (T-Spot)
- 2. The student may choose either blood test: A positive result from an IGRA test requires a physical examination by a qualified healthcare provider and a chest x-ray. =In addition, a letter outlining the diagnosis and plan of care must be submitted to the Nursing Department before a student attends any clinical experiences.
- 3. <u>Tuberculosis Risk Assessment Form</u>: A tuberculosis risk assessment form must be completed by each student annually and when the student has traveled outside of the United States. Students who have traveled to TB endemic areas as described by the Centers for Disease Control and Prevention may be required to undergo additional testing. TB screening policies may vary by clinical agency. Students must comply with agency policy.

### Measles, Mumps, Rubella, and Rubeola

Students are required to show proof of immunity to the following communicable diseases:

- 1. Proof of one (a) rubella immunization or rubella titer (may be MMR)
- 2. Proof of two (b) rubeola vaccines or rubeola titer (may be MMR)
- 3. Verbal history of chickenpox or varicella zoster titer

Your family health care provider may verify immunization dates. Titers may be drawn by a healthcare provider or through Health and Wellness Services. Students are responsible for the costs of the titers.

#### Influenza Vaccine

Each fall, students must submit proof of obtaining a yearly influenza vaccine. Flu vaccine documentation is due October 31.

#### **Hepatitis B Vaccination**

The Department of Nursing Science in collaboration with clinical agencies requires that nursing students receive the <u>Hepatitis B vaccine</u>. Hepatitis B vaccine may be obtained from your family healthcare provider or through Health and Wellness Services. The vaccination consists of a series of three injections. Students must begin the injections at least one month prior to beginning clinical; the second injection will follow in one month. The final injection is to be given six months after the first injection. It is not necessary that the series be completed at one location. The Hepatitis B series is available for a fee from Health and Wellness Services. If the series is started with your family healthcare provider, you can get the other injections from Health and Wellness Services. If for some medical, religious, or philosophical reason, the student elects not to receive the vaccine, a letter stating such must be signed, dated, and submitted by the student prior to clinical practicum. Failure to either receive the vaccine or sign a declination form will result in denial of admission to the major.

#### Tetanus

<u>Proof of tetanus immunization</u> is required. An updated tetanus (Td) booster vaccination is strongly advised if it has been over 10 years since your last tetanus vaccination.

#### COVID-19

Beginning with courses offered in summer 2023, the COVID-19 vaccines/boosters are no longer a requirement for enrollment at Saint Mary's College. Because we are a congregate-living residential community, we are strongly recommending members of the Saint Mary's College community remain up-to-date with the COVID-19 vaccine and booster, including the most recent booster. The Department of Nursing Science is required to report nursing students' <u>COVID-19</u> <u>vaccination status</u> to affiliated clinical agencies. COVID-19 declinations and vaccination exemptions must be sent directly to the Department of Nursing Science.

#### **CPR Certification**

The Department of Nursing Science requires all nursing students to be CPR certified. The CPR course must be two-year certification from the American Heart Association (AHA) Basic Life Support (BLS) Healthcare Provider course that includes AED training and requires a skills checkoff on a mannequin. The AHA HeartSaver course is unacceptable; you must take the BLS course for healthcare professionals. CPR certification must remain current throughout your clinical courses. A copy of the CPR certification card must be submitted to the Nursing Department.

Please note that our clinical site affiliates do not currently accept BLS certification from other entities. CPR certification obtained from an agency other than the AHA is not acceptable. Students will not be permitted to participate in clinicals until they submit proof of CRP certification from the AHA BLS Healthcare Provider course.

## **Department Academic Policies**

#### **Academic Performance**

It is expected that every student in the Department of Nursing Science will adhere not only to Saint Mary's College Community Conduct Code but also to the American Nurses Association Code of Ethics for Nurses. The statement of the Code, included in the Student Handbook, provides guidance for conduct and relationships in carrying out nursing responsibilities consistent with the ethical obligations of the profession and quality of nursing care. The Department of Nursing Science faculty is responsible for making decisions regarding the appropriateness of student performance in nursing courses.

Students who are performing below the 76% level in a course at mid-term will receive a deficiency notice. The department chair is informed of student deficiencies. Failure to receive a mid-semester deficiency notice does not preclude the possibility that the student may still fail the course, nor does it imply that the student will automatically pass the course. Mid-semester deficiencies do not become part of a student's official record. Deficiency notices are available online through PRISM.

#### **Academic Advising**

- Beginning with the second semester of the first year, intended nursing students will be advised by the academic advisor for the Department of Nursing Science.
- Students can request access to their advisement records.
- Students are expected to come to their advising meeting prepared with their academic plan completed.
- Students are responsible for registering for their own courses through Prism including the nursing courses.
- The student must notify the academic advisor of involvement in officially sanctioned cocurricular activities and sports. Students who fail to communicate this information at the time of advising will not be guaranteed accommodations or a change in their schedule.

### **Student Academic Responsibilities**

Nursing is a practice-based profession rooted in the art and science of caring. Becoming a nurse requires dedication to learning; therefore, we expect students to:

- be punctual and attend all scheduled classes, clinicals, and seminars,
- notify the professor in advance of all absences,
- complete all reading assignments,
- take notes in class,
- ask questions to clarify information,
- practice nursing skills in the lab,

- prepare for patient care according to course expectations,
- bring all required materials to class and clinical,
- check your email for faculty communication.

For every hour of classroom instruction, students should expect to spend a minimum of 3 hours studying for the course. A student enrolled in two 5-hour courses can expect to study a minimum of 30 hours per week.

Textbooks are carefully chosen for every course, and students must acquire the required course materials and complete reading assignments and activities. Examinations will contain information that may not have been covered in class but was assigned for class prep and readings.

Students experiencing an illness or life event that may negatively impact their performance are encouraged to discuss the issue with their professor immediately. The faculty member may refer the student to the Dean of Students.

#### **Trigger Warnings**

Content in nursing courses will include sensitive topics, and some students may have an emotional response to it. If you must leave the room during the presentation of the information, you may ask a classmate for notes. You will still be responsible for knowing the information. Your faculty encourages you to engage in self-reflection, self-assessment, and consider your thoughts and feelings about the topic to help care for patients with "problematic" histories as a nurse.

If you feel you need it, your faculty encourages you to get help from a professional. At Saint Mary's, you have 24/7 access to Free On-Demand Mental Health Services through a new service called <u>Timely Care</u>. You can access Timely Care through your cell phone or computer. You can also contact the Health and Counseling Center (located inside of the Angela Athletic & Wellness Complex) at 574-284-4805 for an appointment. Call 911, your doctor, or a crisis intervention specialist in an emergency. Alternatively, you can go to a medical or psychiatric clinic for immediate care. Don't feel you have to stay isolated or alone; know that the professionals you are contacting are there to help and support you. #### Communication

The Saint Mary's College email system is the official method for communicating electronically with faculty members. It is a professional obligation that students check their Saint Mary's College email and BlackBoard on a daily basis. The student is responsible for frequently monitoring these communication channels and responding in a timely manner.

Faculty members make every effort to respond to emails within 48 hours. If a student does not receive a reply within this timeframe, the student is encouraged to send another email as a courtesy to the faculty member. Non-emergent emails that are received by faculty during the weekend may not be answered until the next standard working day.

If a faculty member provides a cell phone number and permits students to call or text message, this communication should only pertain to clinical or course issues and be within the standard working day, Monday through Friday, 8:00 A.M. to 5:00 P.M., or during approved clinical course times outside of these hours. Course or clinical emergency calls or text messages are permitted outside of these hours. Exceptions to this guideline may be granted at the discretion of individual faculty members.

#### **Lines of Communication**

Students who have questions about or issues with a class, must first contact the faculty member who is responsible for that course. When discussing the issue with the faculty member, remember the following:

- 1. Professionalism requires that you discuss the issue first with the course faculty member.
- 2. Be professional: State the issue without making accusations.
- 3. Be clear when you state your case: Include specific information about the issue and what you believe should be done about it.
- 4. Avoid negative or emotional outbursts in person, over the phone, or in an email.
- 5. Give the faculty involved a chance to present their perspective.

Students who have unresolved issues with a course, feel harassed or bullied, have life/work/school balance issues, or any other program questions or issues should contact the BSN Program Director to discuss the issue. If the student is still dissatisfied, the next person the student should communicate with is the Director and Chair of the Department of Nursing Science. Professionalism requires students to follow this line of communication policy.

### Civility

Consistent with the values of Saint Mary's College, the American Nurses Association Code of Ethics for Nurses, and the Essential Abilities, all communication and interactions with students, faculty, preceptors, clinic staff, and patients must reflect professional standards. This means communication must be clear, concise, civil, and professional. Harassment and demeaning communication and interactions are not tolerated.

Students must contact the course lead faculty directly should any course-related concerns arise. Class attendance, preparation, and participation are a demonstration of professional behavior. The interaction between students and the faculty in the learning community will maximize the opportunity for sharing and learning together. Consistent with this goal, it is expected that diverse perspectives and opinions will be expressed (whether verbally or in writing) and be received in a respectful and professional manner. Incivility, intolerance, hate speech, abusive behaviors, and deceitful behaviors are considered professional misconduct and will not be tolerated. Students who demonstrate uncivil behavior will receive a probationary learning contract and be subject to further disciplinary action.

## **Department Clinical Policies**

### **Clinical Experience**

Clinical experiences will be provided in a variety of institutions and settings in the community.

#### Clinical Pre-Assessment

Some clinical rotations require pre-assessment of assigned patients prior to the clinical experience. Students are expected to conduct themselves professionally at all times while pre-assessing. The nursing uniform is required for pre-assessment. Students are not allowed to do any nursing care during pre-assessment. Students are prohibited from printing, photocopying or taking photographs of any information from a patient's medical record as this is considered a breach of patient confidentiality and may result in a clinical failure and dismissal from the program.

### Accountability

Accountability is demonstrated by fulfilling responsibilities and expectations for professional behavior as described in each clinical course syllabus. Students may not take verbal or telephone orders from any healthcare provider.

### Confidentiality

It is a professional requirement to maintain confidentiality regarding client and family information. Each year, students must complete a HIPAA module and sign a <u>statement on confidentiality</u> prior to clinical experiences.

## Transportation

Students are responsible for their own transportation to/from all clinical agencies.

#### **Dress Code**

As nurses and nursing students it is our role to care for the public in many settings. It is important to present a professional image as well as be mindful of disease transmission. The clinical dress code for the Saint Mary's College nursing majors in collaboration with clinical agencies is as follows:

- 1. Uniforms, a lab coat, a name badge, a stethoscope, and a watch with a second hand are necessary for laboratory and clinical courses.
- 2. Students must purchase navy blue scrubs for the Sophomore level laboratory courses.
- 3. Prior to entering clinical coursework in the Junior year, students must buy the official uniform top, pants, and lab coat that are purchased through MorU.

- 4. Shoes must be white and clean. Athletic shoes are permitted if they are made of white leather. White canvas, cotton, or nylon shoes are unacceptable. White shoelaces are required. Shoes with an open toe or heel, or clogs may not be worn.
- 5. The white lab coats are optional when worn with the clinical uniform. They may be required for specific clinical sites.
- 6. When students are involved in direct patient care, a white undershirt or turtleneck may be worn under the top. No sweaters, sweatshirts, or hoodies are permitted.
- 7. Uniforms must be worn for patient pre-assessment.
- 8. Uniforms may not be worn to social events outside of clinical settings.
- 9. Hair that falls below shoulder length must be pulled back. Earrings must be single, stud type, no dangling earrings. Jewelry is limited to watches and inconspicuous rings (such as wedding rings/bands). Fingernails must be neat, clean, and trimmed. No artificial nails or nail polish may be worn. Make-up should be simple. Cologne and perfumes may not be worn.
- 10. The community health clinical sites are widely varied and may have different requirements and expectations of student dress. The syllabus for NUR414 will outline the specific requirements of each site and/or individual instructions will be discussed with the students assigned to each clinical site.
- 11. Students must present a professional image in all clinical settings. Short skirts, shorts, blue jeans, low necklines, bare midriffs, and leggings are not considered part of a professional appearance.
- 12. Students who do not adhere to the uniform policy will be sent home and the missed time will be counted as unexcused.

## **Eating in Patient Care Areas**

Students are not permitted to eat or drink in any patient care areas. Gum chewing is not permitted during clinical time.

## Clinical Probation / Failure

Safe and professional patient care is the minimal standard for progression in clinical courses. If a student is not demonstrating safe and/or professional care, the clinical faculty will draft a <u>probationary learning contract</u> based on the student's unsatisfactory performance. The <u>probationary learning contract</u> will outline a remediation plan and will be discussed verbally and presented in writing to the student. Students are required to remediate as directed by the clinical faculty in order to improve their performance in the clinical setting. It is expected that these recommendations will provide the guidance needed for the student to successfully pass the course and progress in the nursing program.

When the student's performance/behavior has improved and/or the unsatisfactory behavior has been changed as determined by the instructor, a notation will be made on the <u>probationary learning contract</u> of the student's improvement. The <u>probationary learning contract</u> remains in the student's record in the Department of Nursing Science with other documentation of clinical performance.

If after the required remediation, the student's clinical performance continues to be deemed unsafe or unprofessional by the clinical faculty, the student will earn a clinical failure. Students who earn a didactic and/or clinical failure must repeat the entire course.

Critical incidents or events that could cause harm to a patient must be immediately reported to the student's clinical faculty. Critical incidents that are not immediately reported to the clinical faculty may result in clinical failure. The faculty member will work with the students to fill out pertinent incident-reporting paperwork.

Students who exhibit impaired behavior will be dismissed from the clinical setting and must undergo immediate drug testing (see <u>drug screening and student impairment policies</u>). Students who test positive and do not receive Medical Review Officer review and clearance will receive an immediate clinical failure.

### **Clinical Conduct Expectations**

It is expected that every student in the Department of Nursing Science will adhere to the Saint Mary's College Code of Student Conduct and the American Nurses Association Code of Ethics for Nurses. The Code of Ethics provides guidance for conduct and relationships in carrying out nursing responsibilities consistent with the ethical obligations of the profession and quality in nursing care.

The Department of Nursing Science maintains contractual agreements for student experience with a variety of agencies. Students must meet the expectations of both the department and the agency for appropriate professional conduct and attire. If a student cannot demonstrate the ability to deliver safe care at the level required in a course, the instructor has a responsibility to remove the student so that the safety and welfare of clients are not compromised. For example, a student arriving in the clinical/laboratory area unprepared for the day or administering medications without knowing why certain drugs are being given would not be administering safe, informed care to his/her client.

## Needlestick and Bloodborne Pathogen Exposure

Bloodborne pathogens are infectious microorganisms in human blood that can cause disease in humans. Bloodborne pathogens include but are not limited to, hepatitis B (HBV), hepatitis C (HCV), and human immunodeficiency virus (HIV). A bloodborne pathogen exposure is contact with blood or other potentially infectious material in the eye, mouth, mucous membranes, non-intact skin, or parenteral contact.

The Department of Nursing Science is committed to the safety and prevention of needlestick injuries and bloodborne pathogen exposure. In the event of needlestick injuries and bloodborne pathogen exposure, students must report it immediately to the clinical faculty member. The clinical faculty member then notifies the course lead faculty and the BSN Director of the incident immediately. The clinical faculty member will work with the student, the course lead faculty, and the BSN Program Director to fill out pertinent incident-reporting paperwork.

If the incident occurs when the Health and Counseling Center is not open (hours are Monday-Friday, 8:00 A.M. - 5:00 P.M.), the faculty member will call Security who will inform the faculty of the Health and Counseling Center staff who is on call. The HCC staff member will schedule an appointment for the student on Monday for bloodborne pathogen testing.

If you experienced a needlestick and/or were exposed to blood, immediately:

- Wash the needlestick area and surrounding skin with soap and water.
- Flush splashes to the nose, mouth, or skin with water.
- Irrigate eyes with water, saline or irrigate with a sterile solution.
- Report the incident to your clinical faculty.
- The student is to follow up with the Health and Counseling Center. Students are responsible for the costs of elective evaluation outside the Health and Counseling Center.
- The student is to follow up with their health care provider if bloodborne pathogen lab results are abnormal.

## **Student Life**

#### **Student Nurses Association**

The Student Nurses Association (SNA) is a pre-professional association of nursing students at Saint Mary's College. Involvement in SNA promotes leadership and prepares students for involvement in professional associations upon graduation. Nursing students may also wish to join the National Student Nurses' Association (NSNA). Members of the NSNA are eligible and encouraged to attend national and state offerings.

### Nursing Student Alliance for Inclusion and Diversity

The Nursing Student Alliance for Inclusion and Diversity (NSAID) is a student-led club for all nursing majors. The mission of NSAID is to:

- To create awareness of diversity to bring together those called to nursing by providing academic and social activities, and any other activities suggested by its members that uplift, motivate, and support, creating a more inclusive environment for diverse populations within the Saint Mary's College community.
- With this increased awareness, address inequalities, generate action within the Saint Mary's College community, and increase the diversity of the nursing workforce.

#### The purpose of the NSAID is to:

- To foster more inclusive spaces for diverse populations on campus to promote nursingcentered success, social justice, community, and belonging.
- To identify and challenge barriers that impede the growth and development of a diverse learning environment.

In addition, each student who participates as a Student Affiliate Member will have the opportunity to affiliate with registered nurses and explore current nursing issues, witness ISNA districts/regions in action, associate with Indiana's nursing leaders and to network with nurses who are active in their professional organization. The experience will enable students to obtain skills they will use throughout their nursing careers.
